

DESCRIPTION OF SURVEY FOR R & L HILES

JOB#1150

Situated in the State of Ohio, County of Muskingum, Township of Springfield:

Being part of the Northwest Quarter, of Section #14, Township #16, Range #14, of the Congress Lands East of the Scioto River, **being all of the Ralph & Lee Ann Hiles** property described in Deed Book Volume 686, Page 221 of said county's deed records, known as **Muskingum County Auditor's Parcel Number 62-48-01-10-000**, and more particularly described as follows;

Commencing at a stone (found) at the Northeast corner of the Northwest Quarter of Section #14, also being the common corner for the Northeast Quarter of Section #14 and Southeast and Southwest Quarters of Section #11 of said Township and Range; **THENCE South 05 degrees 00 minutes 00 seconds West 1235.39 feet** along the common line for the Northeast and Northwest Quarters of Section #14 to an iron pin (set) at the common corner for said Hiles property and for the D & T McKee property recorded in Deed Book Volume 1155, Page 110, also being the place of beginning of the property herein intended to be described;

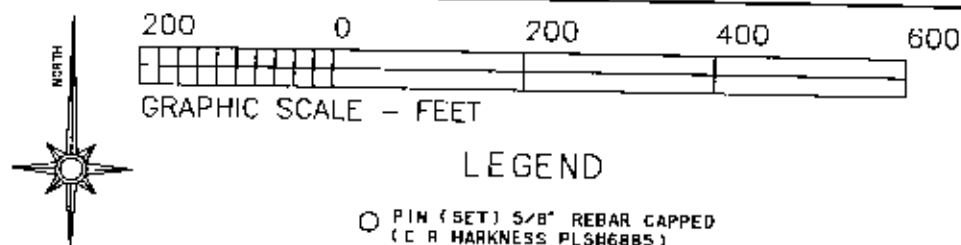
- #1- **THENCE South 05 degrees 00 minutes 00 seconds West 100.00 feet** continuing along said common quarter section line to an iron pin (set) at the common corner for said Hiles property and for the T Edwards property recorded in Deed Book Volume 569, Page 876;
- #2- **THENCE North 85 degrees 26 minutes 30 seconds West 792.06 feet** into said Northwest Quarter and along a common line for said Hiles and Edwards properties to the unmarked common corner for said Hiles and Edwards properties in the center line of Potts Lane (County Road #143), passing an iron pin (set) at 758.42 feet;
- #3- **THENCE North 02 degrees 26 minutes 20 seconds West 100.75 feet** along said road to an unmarked common corner for said Hiles and McKee properties;
- #4- **THENCE South 85 degrees 26 minutes 30 seconds East 805.10 feet** leaving said road and along the common line for said Hiles and McKee properties to the place of beginning, passing an axle (found) at 23.39 feet, **containing 1.83 acres.**

The bearings within this description are based on the East line of the Northwest Quarter of Section #14 as described in Deed Book Volume 686, Page 221. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).
