

Situated in the State of Ohio, County of Muskingum, Township of Springfield:

Being part of Northwest Quarter, Section 14, Township 16, Range 14, of the Congress Lands East of the Scioto River, further **being part of** the Ermina E McElroy property recorded in Official Record Volume 2410, Page 508, of said county's deed records, further being **part of** Muskingum County Auditor's Parcel Number **62-48-01-50-000**, and more particularly described as follows;

Commencing at an iron pin (found) at the Southwest corner of Lot 5 of Hideaway Acres recorded in Plat Book 10, Page 20, also being the Northwest corner of the Tommy E Tipton and Debra S Tipton property recorded in Deed Book Volume 784, Page 115, further being on the East line of a private road Stalder Drive, and property line of Jacquelyn M Smith property recorded in Official Record Volume 2325, Page 779;

TIE-1 THENCE South 02 degrees 23 minutes 15 seconds West 183.80 feet along the common line for said Tipton and Smith properties, also the East line of said private road to the unmarked Southwest corner of said Tipton property;

TIE-2 THENCE South 04 degrees 01 minutes 45 seconds West 133.38 feet along the said McElroy and Smith properties, East line of said private road, also the East line of the Chad A James and Billie J James property recorded in Official Record Volume 2125, Page 204 to an iron pin (set) at the place of beginning for the property herein intended to be described;

#1- THENCE South 83 degrees 14 minutes 05 seconds East 851.13 feet crossing said McElroy property to an unmarked point in the centerline of Potts Lane, passing an iron pin (set) at 826.13 feet;

#2- THENCE along a curve to the right having, a chord bearing South 07 degrees 17 minutes 45 seconds West 172.07 feet, a radius of 405.01 feet, and arc length of 172.75 feet, along Potts Lane to the unmarked Northeast corner of the Michael L Jacolenne and Theresa Jacolenne property recorded in Official Record Volume 1511, Page 706;

#3- THENCE North 79 degrees 39 minutes 05 seconds West 673.55 feet along said McElroy and Jacolenne properties to an iron pipe (found) at a corner of said James property, passing an iron pin (found) at 32.00 feet;

#4- THENCE North 87 degrees 15 minutes 55 seconds West 170.95 feet along said McElroy and James properties to an iron pipe (found);

#5- THENCE North 04 degrees 01 minutes 45 seconds East 142.14 feet continuing along said McElroy and James properties to the place of beginning, **containing 2.90 acres**, of which 0.08 acres are within the right of way for Potts Lane.

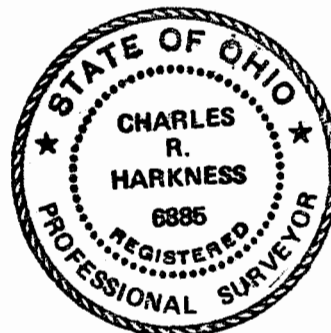

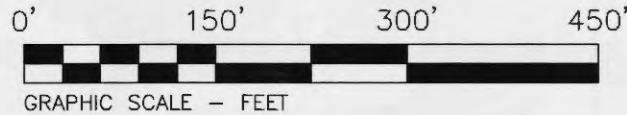
