BEING A PART OF THE SOUTHWEST QUARTER OF SECTION 15, TOWNSHIP 12, RANGE 13, OF THE CONGRESS LANDS EAST OF THE SCIOTO RIVER, SPRINGFIELD TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHWEST CORNER OF THE SOUTHWEST QUARTER OF SECTION 15;

THENCE SOUTH 86 DEGREES 37 MINUTES 28 SECONDS EAST 1019.81 FEET, ALONG THE SOUTH LINE OF THE SAID SOUTHWEST QUARTER, TO AN EXISTING IRON PIN, SAID IRON PIN BEING THE SOUTHEAST CORNER OF A 1.38 ACRE TRACT CONVEYED TO J. G. FINK BY DEED RECORDED IN VOLUME 944, PAGE 90 OF THE MUSKINGUM COUNTY DEED RECORDS;

THENCE WITH THE EAST LINE OF THE SAID 1.38 ACRE TRACT, NORTH 03 DEGREES 31 MINUTES 00 SECONDS EAST 150.00 FEET TO AN IRON PIN SET, SAID IRON PIN BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED;

THENCE CONTINUING NORTH 03 DEGREES 31 MINUTES 00 SECONDS EAST 87.89 FEET TO AN EXISTING IRON PIN (3/4" REBAR) ON THE SOUTH LINE OF COUNTY ROAD 625 (EAST MAIN STREET);

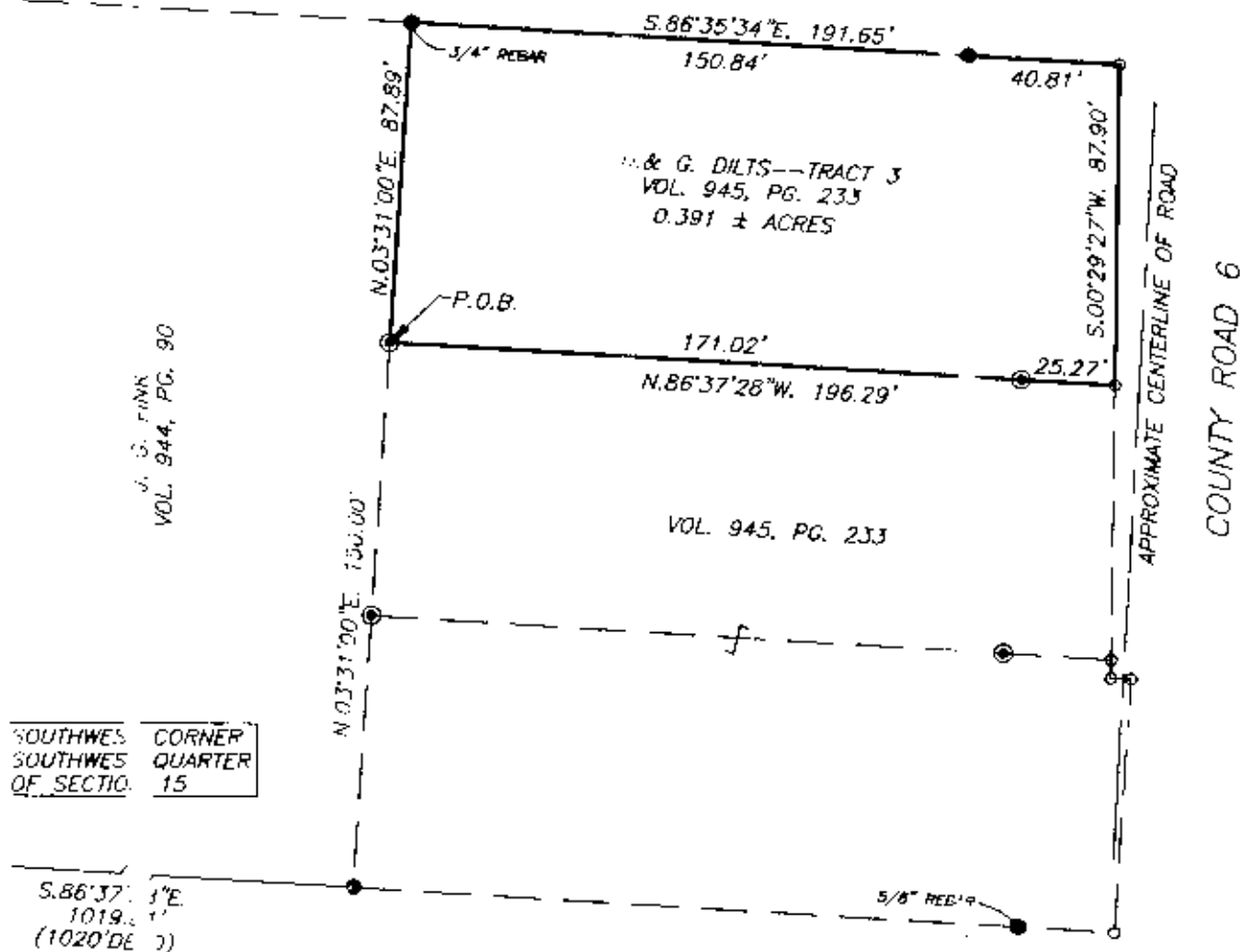

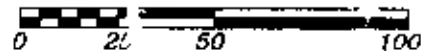
TOWNSHIP RD. 625 (EAST MAIN STREET)
