Subject to the easements of East Main Street (Township Road #625) and County Road #6.

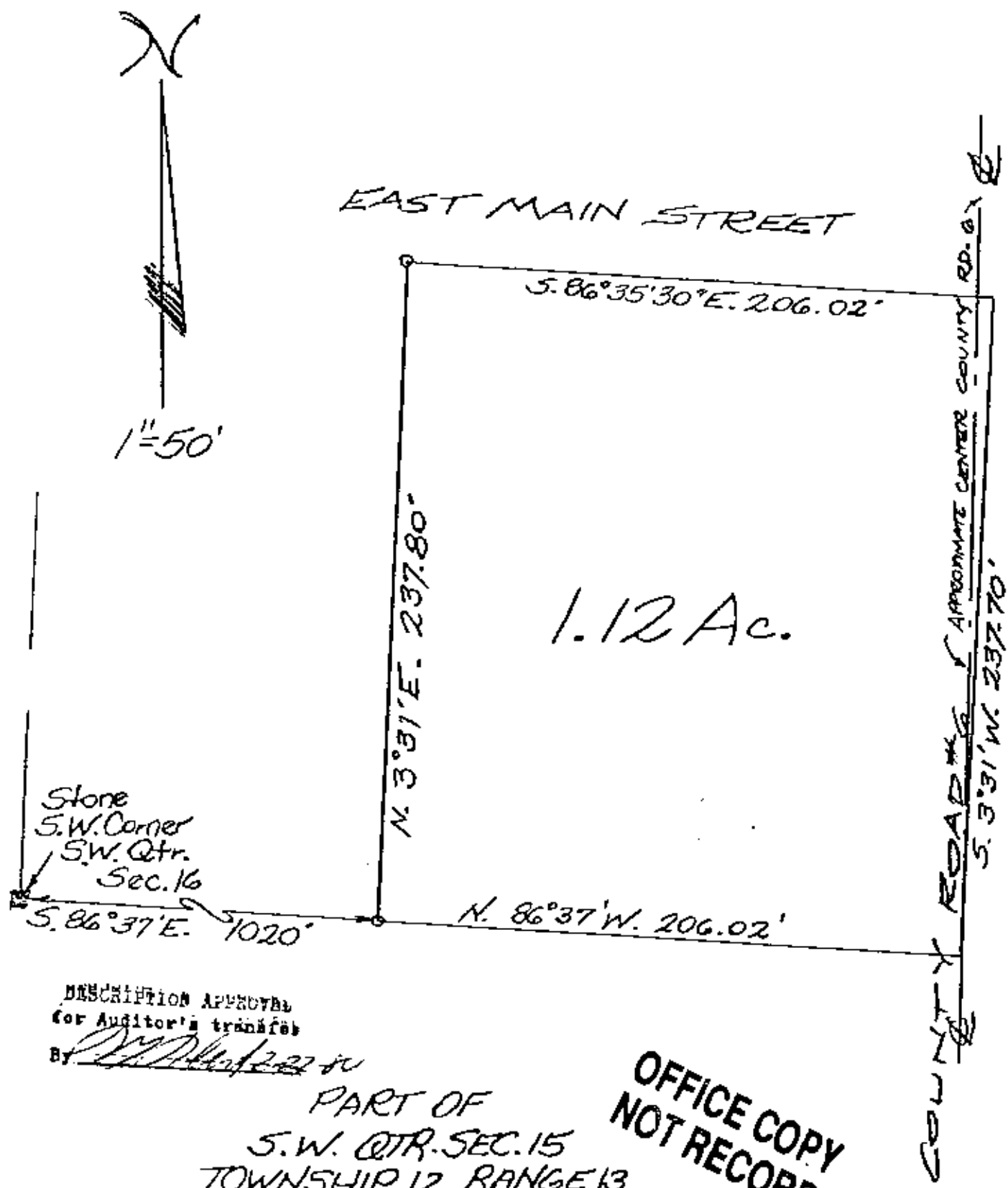

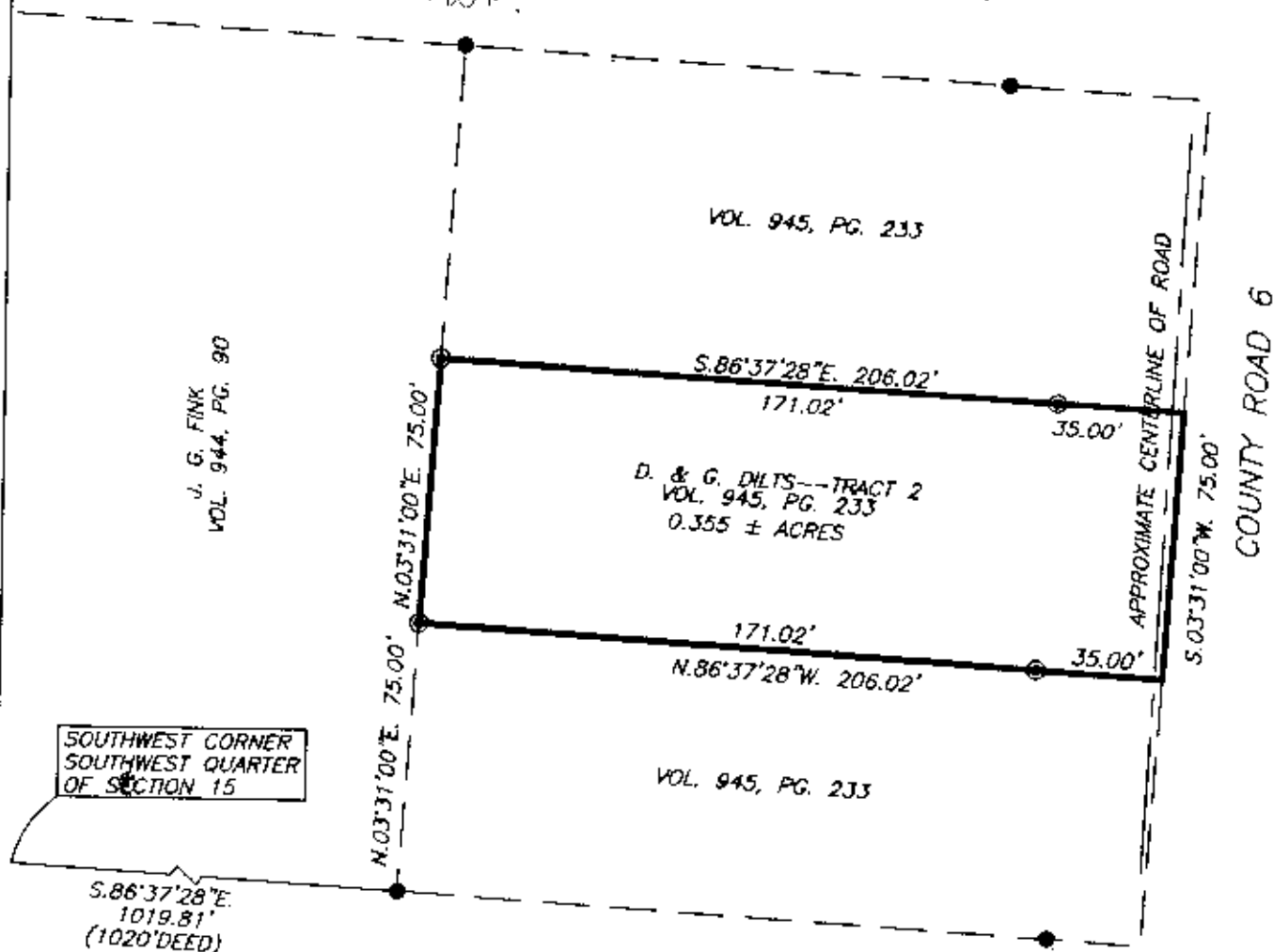

TAX MAP

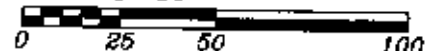

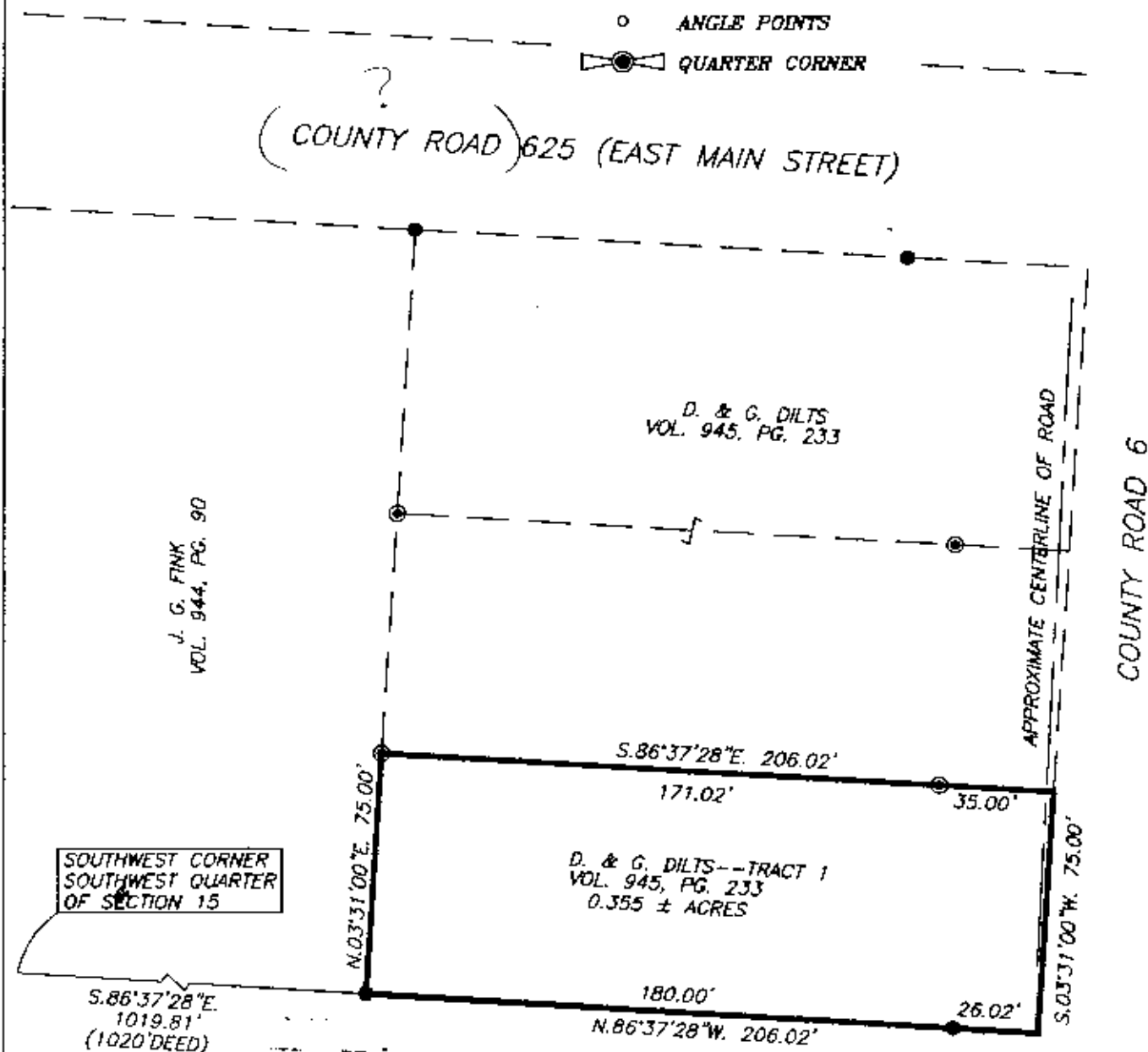

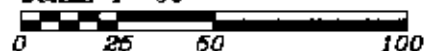
