Situated in the State of Ohio, County of Muskingum, Township of Springfield.

Being a part of the Southwest Quarter of Section 15, Township 12, Range 13 bounded and described as follows:

Commencing at a stone found at the Southwest Corner of said Section 15; thence east 1226.02 feet to a point in the center of County Road #6 (Old River Road); thence along said centerline north 2 degrees 30 minutes west 71.40 feet to the true place of beginning of the property herein intended to be described; thence continuing along said centerline north 2 degrees 30 minutes west 206.20 feet to a point; thence on a curve to the right having a radius of 478.34 feet an arc length of 79.37 feet (the chord of which bears north 2 degrees 15 minutes 13 seconds east 79.28 feet) to a point; thence leaving said road south 88 degrees 30 minutes 28 seconds east 219.49 feet to a point in the center of Moxahala Creek; thence up said creek south 5 degrees 23 minutes 27 seconds west 277.46 feet to a point; thence leaving said creek south 89 degrees west 187.50 feet to the true place of beginning, containing one and thirty-three hundredths (1.33) acres more or less.

Subject to the easements of County Road #6.
