Description For Conveyance  
5.42 Acre Parcel

Situated in the State of Ohio, County of Muskingum, Township of Springfield.

Being a part of the Northeast Quarter of Section 3, Township 15, Range 14 bounded and described as follows:

Beginning at a point on the north line of Section 3, west 977.45 feet from the northeast corner of Section 3; thence south 82 degrees 36 minutes 51 seconds west 401.10 feet to a point; thence around a culdesac on a curve to the left having a radius of 50 feet and arc distance of 78.54 feet to an iron pin; thence south 82 degrees 36 minutes 51 seconds west 190.35 feet to an iron pin; thence south 0 degrees 11 minutes 21 seconds west 363.63 feet to an iron pin; thence south 83 degrees 31 minutes 13 seconds west 389.04 feet to an iron pin; thence north 0 degrees 01 minutes 28 seconds west 539.57 feet to an iron pin; thence east 1017.69 feet to the place of beginning, containing five and forty-two hundredths (5.42) acres more or less.

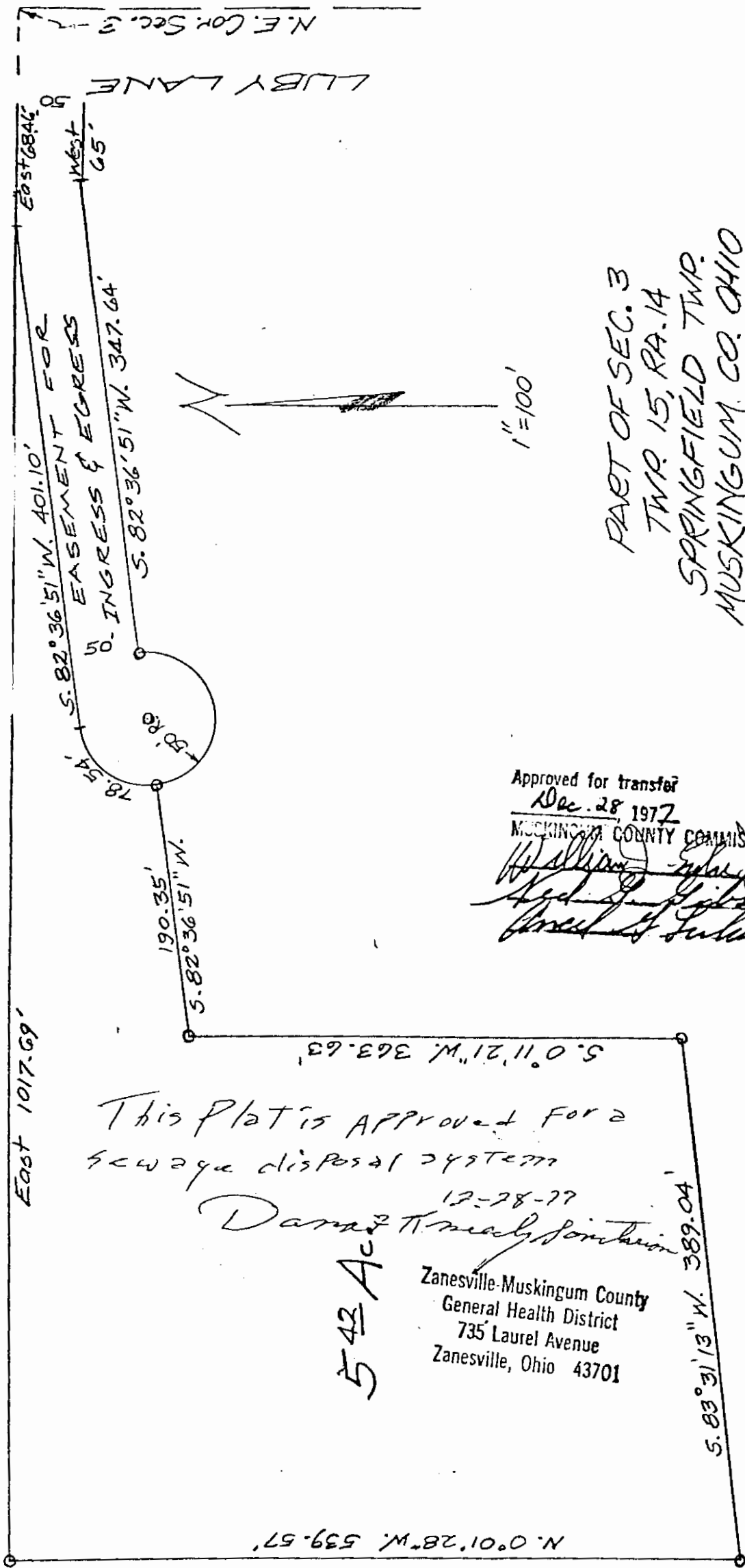
There is also hereby conveyed an easement for ingress and egress bounded and described as follows:

Beginning at a point in Luby Lane at its intersection with the north line of Section 3; thence along said Luby Lane south 50 feet to a point; thence leaving said Luby Lane west 65 feet to a point; thence south 82 degrees 36 minutes 51 seconds west 347.64 feet to an iron pin; thence around a culdesac to the left having a radius of 50 feet an arc distance of 235.62 feet to a point; thence north 82 degrees 36 minutes 51 seconds east 401.10 feet to a point on the north line of the aforesaid Section 3; thence east 68.46 feet to the place of beginning.
