THENCE WITH THE SOUTH LINE OF THE SAID NORTHEAST QUARTER OF SECTION 3 (ALSO BEING THE SOUTH LINE OF SPRINGFIELD TOWNSHIP), NORTH 87 DEGREES 04 MINUTES 25 SECONDS WEST 1224.96 FEET TO A POINT AT THE SOUTHEAST CORNER OF A PARCEL CONVEYED TO MARLA E. MORRIS IN O.R. VOLUME 2896, PAGE 846 IN PINKERTON ROAD (COUNTY ROAD 125), SAID POINT BEING THE **PLACE OF BEGINNING** FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED;
