

DESCRIPTION OF SURVEY FOR GABE WEATHERSPOON JOB #424-2

Situated in the State of Ohio, County of Muskingum, Township of Springfield, Northwest Quarter, of Section #2, Township #15, Range #14, of Congress Lands East of the Scioto River:

Being part of the prior deed reference Volume 1060, Page 286 of said county's deed records, also part of Muskingum County Auditor's Parcel Number 62-62-70-03-03-000, and more particularly described as follows;

Beginning at an iron pin (found) at the Northwest corner of said Section #2; thence along the North line of said Section #2 S 87 35 00 E 815.90 feet to an iron pin (found) at the Northwest corner of the R & L Graham property as described in deed reference Volume 658, Page 272; thence along the West line of said Graham property S 01 42 18 W 153.78 feet to an iron pin (found) at a common corner of said Graham property and the K & P Miller property as described in deed reference Volume 1060, Page 286; thence along a North line of said Miller property also being a line of the Gabe Weatherspoon property as described in deed reference Volume 1055, Page 615 N 88 21 02 W 107.16 feet to an iron pin (set) at the place of beginning for the property herein intended to be described;

- #1- thence through said Miller property S 01 50 28 W 100.80 feet to an iron pin (set) on the South line of said Miller property also being a line of said Weatherspoon property;
- #2- thence along a common line between said Miller and Weatherspoon properties N 87 46 57 W 100.00 feet to an iron pin (found) by previous survey;
- #3- thence along a common line between said Miller and Weatherspoon properties N 01 50 24 E 99.81 feet to an iron pin (set) (replacing an iron pipe found by previous survey destroyed);
- #4- thence along a common line between said Miller and Weatherspoon properties S 88 21 02 E 100.00 feet to the place of beginning containing 0.230 acres.

The bearings within this description are based on the North line of Section #2 as reported in prior deed reference Volume 1008, Page 346. Bearings are shown in a format of Degrees, Minutes, & Seconds. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness R.S.6885).

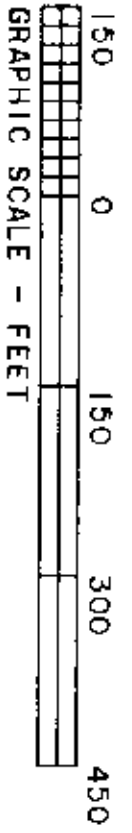

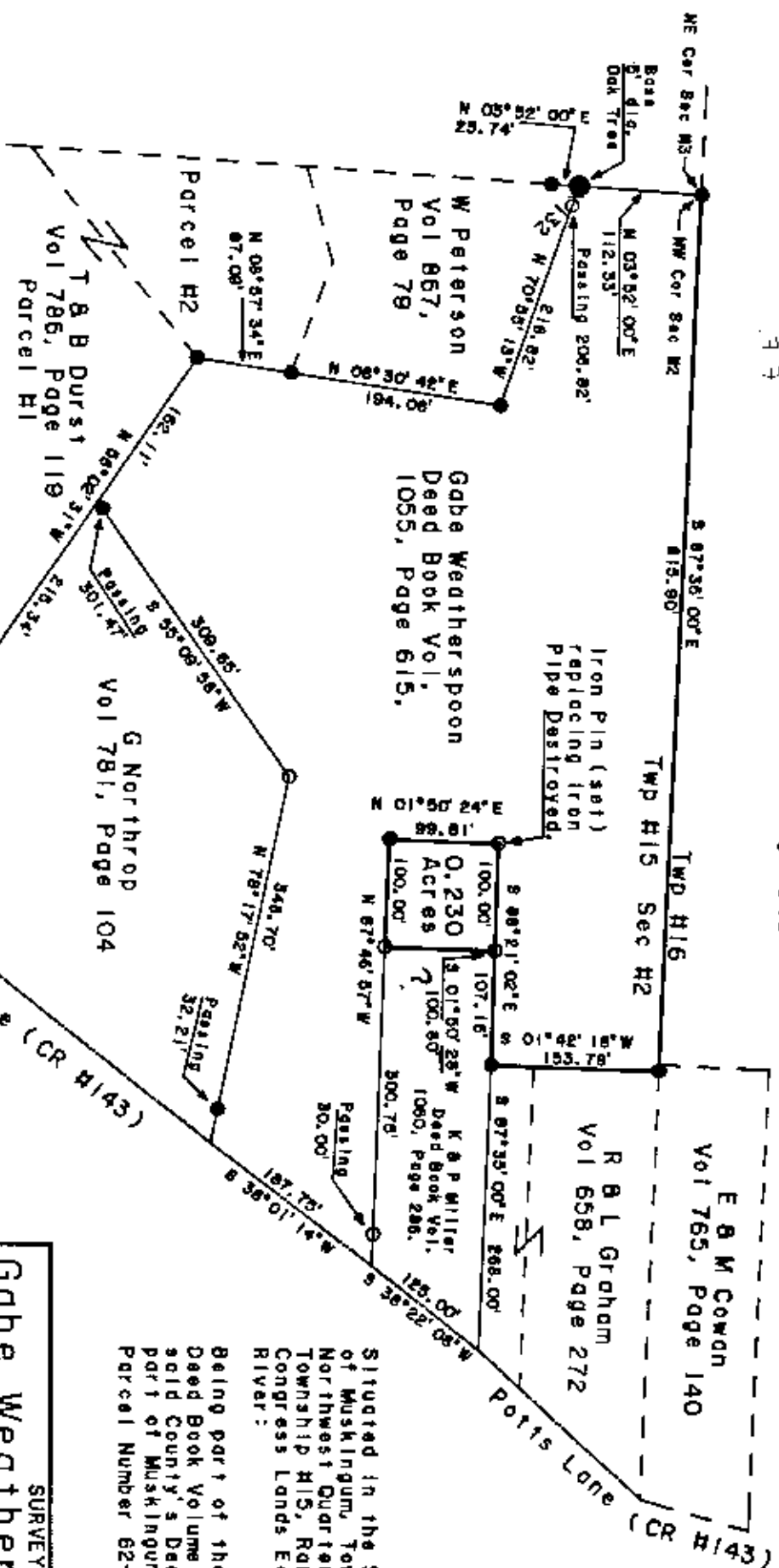
The bearings on the plot are based on the North line of Section #2 as reported. In prior deed reference Volume 1006, Page 348, being N 87° 35' W
