DEED DESCRIPTION

Situated in the State of Ohio, County of Muskingum,
Township of Springfield, T-15, R-14, being part of the
Northwest Quarter of Section 2 in the City of South
Zanesville and more particularly described as follows:

Beginning at an iron pin found at the Southwest Corner of
Lot 64 in Springdale # 5 (plat book 10, page 39); thence
along the South line of Lot 64 South 74 Degrees 36 Minutes
31 Seconds East 69.82 feet to a point and the place of
beginning; thence along the South line of Lots 64 & 63
South 62 Degrees 06 Minutes 50 Seconds East 68.69 feet to a
point on the South line of Lot 63; thence leaving Lot 63
South 00 Degrees 52 Minutes 19 Seconds West 697.05 feet to
a point, passing a stone with an (+) at 10.00 feet and an
iron pipe found at 651.21 feet; thence North 90 Degrees 00
Minutes 00 Seconds West 60.03 feet to a point; thence North
00 Degrees 46 Minutes 46 Seconds East 729.17 feet to the
place of beginning, passing an iron pipe found at 46.15
feet and iron pins found at 308.78 & 709.17 feet. The Tract
as surveyed contains 0.99 acres, more or less, subject to
all legal highways and easements.

EXCEPTING a strip of ground approximately 5 feet wide and
15 feet long (occupied by a garage).

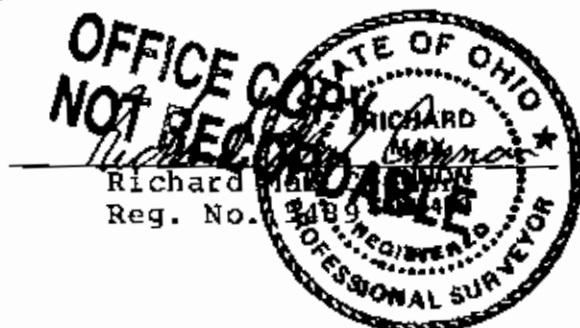

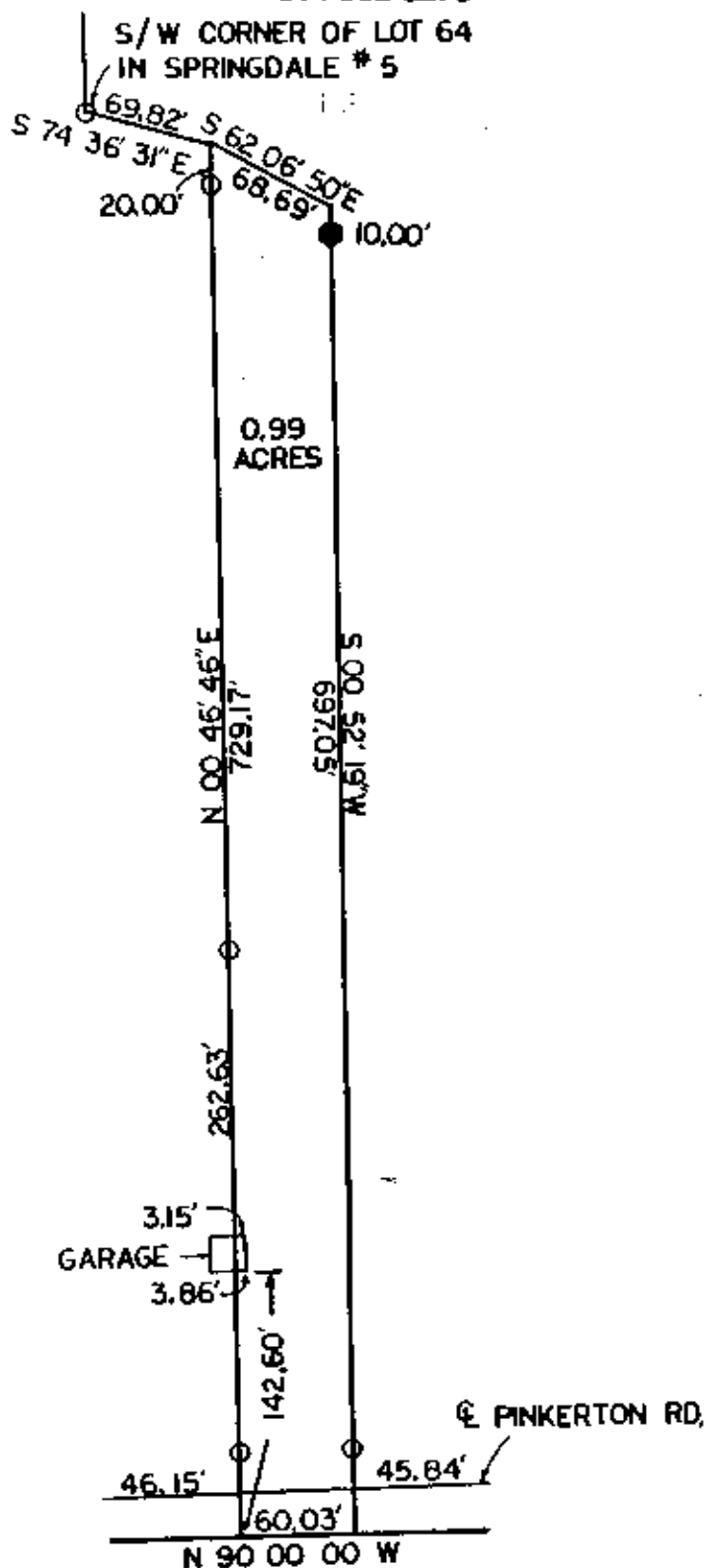
