

LEGAL DESCRIPTION

Located in the northwest quarter of Section 2, Township 15, Range 14, Springfield Township, Muskingum County, Ohio and more particularly described as follows;

Beginning at a stone found at the center of section 2; thence North $0^{\circ}-0'-40''$ West, along the half section line, a distance of 397.15 feet to an iron axle found on the westerly right-of-way line of Sherwood Drive; thence along said right-of-way line on a curve to the left having the following curve data; $R=446.12$ feet, $D=12^{\circ}-50'-35''$, $T=40.72$ feet, central angle $=10^{\circ}-25'-49''$, $L=81.21$ feet, ($C=81.10$ feet, North $26^{\circ}-52'$ West) to an iron axle found; thence continuing along said curve to the left having the following curve data; $R=446.12$ feet, $D=12^{\circ}-50'-35''$, $T=33.26$ feet, central angle $=8^{\circ}-31'-41''$, $L=66.40$ feet, ($C=66.34$ feet, North $36^{\circ}-36'-30''$ West), to an iron pipe and being the true place of beginning of the parcel herein described; thence South $78^{\circ}-30'-20''$ West, a distance of 355.17 feet to an iron pipe on the east line of Lot 2 of Springdale Subdivision as delineated in plat book 9, page 56 of the records of Muskingum County; thence North $11^{\circ}-02'$ West, along the east line of said lot 2, a distance of 18.00 feet to an iron axle found at the southwest corner of Lot 1 of said Springdale Subdivision; thence North $78^{\circ}-20'$ East, along the south line of said Lot 1, a distance of 344.00 feet to an iron axle found on the westerly right-of-way line of Sherwood Drive; thence South $41^{\circ}-50'-40''$ East, along said right-of-way line, a distance of 12.40 feet to a point; thence continuing along said right-of-way line on a curve to the right having the following curve data; $R=446.12$ feet, $D=12^{\circ}-50'-35''$, $T=4.80$ feet, central angle $=1^{\circ}-13'-59''$, $L=9.60$ feet. ($C=9.60$ feet, South $41^{\circ}-13'-40''$ East to the place of beginning.

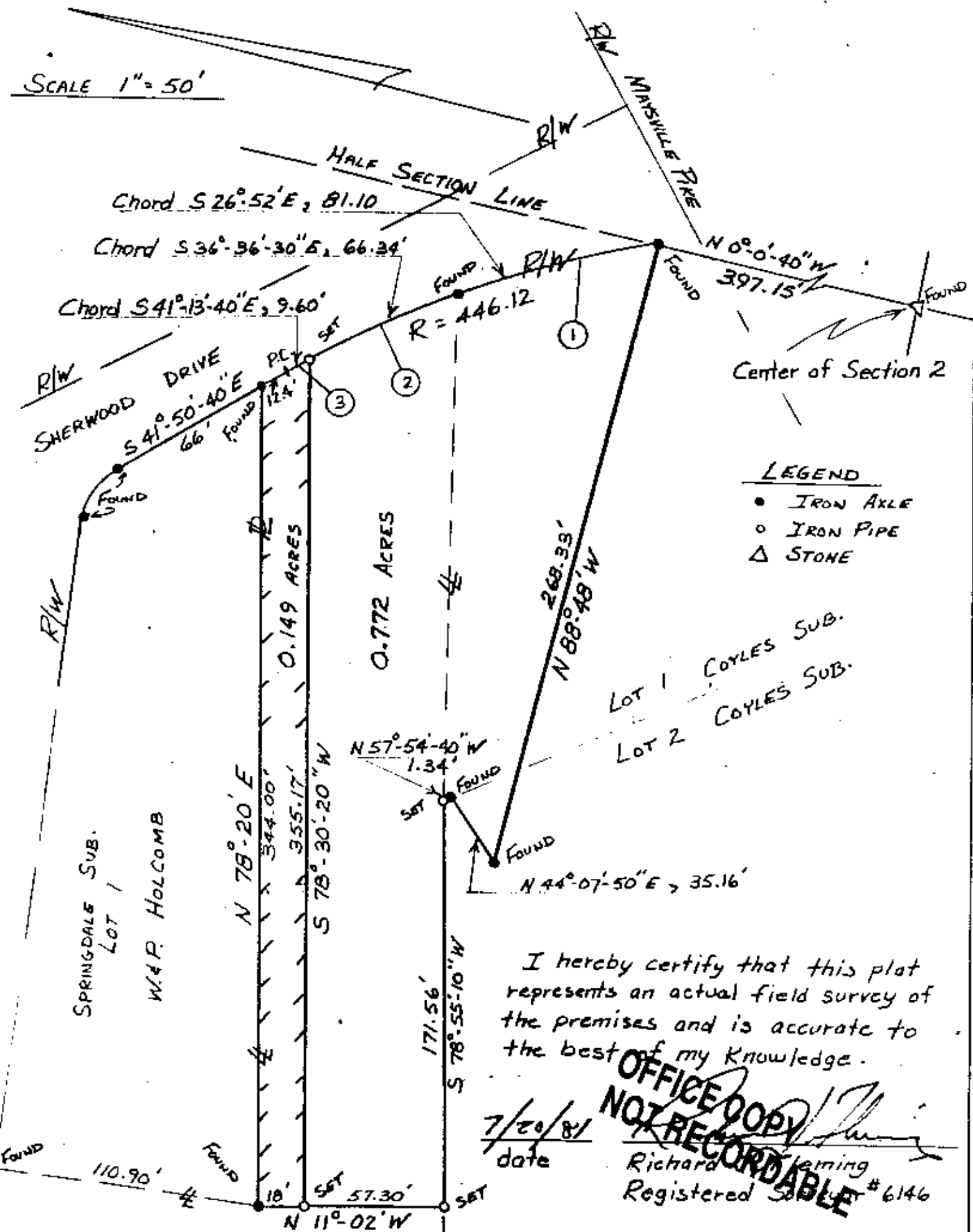
