THENCE WITH THE NORTH LINE OF THE SAID LOT 12 AS CONVEYED TO MATTHEW 1618 LLC IN O.R. VOLUME 3042, PAGE 262, SOUTH 82 DEGREES 36 MINUTES 26 SECONDS WEST 49.77 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR) AT THE SOUTHEAST CORNER OF LOT 2 OF SPRINGDALE SUBDIVISION (PLAT BOOK 9, PAGE 56);
