

**Ray Wilkes (Molley)**

Situated in the State of Ohio, County of Muskingum, Township of Springfield, Township 15, Range 14, Section 2, bounded and described as follows:

Being all of Raymond R. and Raymond J. Wilkes Volume 2064, page 510 (Previous Volume 2017, page 317), Lot 14 and Lot 15 and 30 feet off the South side of Lots 16, 17, 18, and 19 of Zanesville Terrace Addition Plat Book 4, page 74, all of Parcels 62-71-06-02-000, 62-71-06-31-000, 62-71-06-32-000, 62-71-06-33-000, 62-71-06-34-000, and 62-71-06-35-000.

Beginning at an iron pin found at the Southeast Corner of Lot 15 of said Addition; Thence South  $75^{\circ}34'07''$  West along Old Maysville Pike Right of Way Line 57.36 feet to an iron pin set on the corner of Arcadia Avenue; Thence North  $14^{\circ}25'53''$  West along line of Arcadia Avenue 130.00 feet to an iron pin set; Thence North  $75^{\circ}34'07''$  East along Jennie Marie, Martina, and Paula Mayle Volume 2024, page 566, 103.88 feet to an iron pin set; Thence South  $05^{\circ}15'29''$  West along Raymond Wilkes Volume 1121, page 485, 138.07 feet to the place of beginning containing 0.2406 Acres more or less.

Bearings are based on the South line of Section 2 bearing South  $83^{\circ}40'29''$  East.

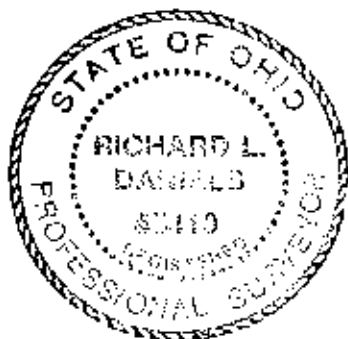

Section 2, T 15, R 14.



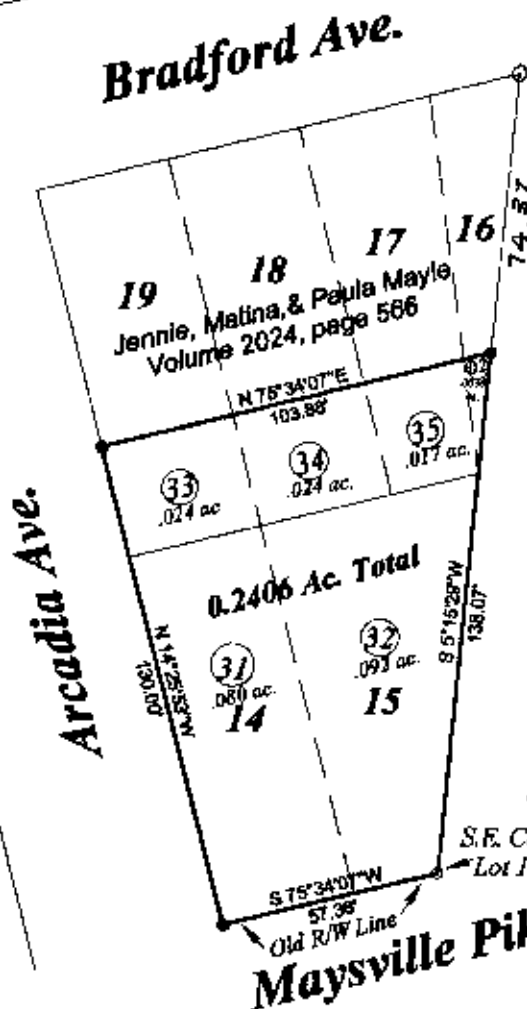
**Basis of Bearings**

- Iron Pin Found



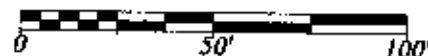
