

Raymond Wilkes

Situated in the State of Ohio, County of Muskingum, Township of Springfield, Township 15, Range 14, Section 2, bounded and described as follows:

Being part of Raymond Wilkes Jr. Property recorded in Deed Vol. , Page , Parcel No. 62-62-72-01-05-000.

Commencing at a stone found at the Southwest Corner of the Northeast Quarter of Section 2; Thence North 5°50'00" East 7.60 feet to an axle found; Thence South 83°29'00" East 664.45 feet to a point; Thence South 83°20'53" East 710.40 feet to a point; Thence North 14°25'53" West 775.03 feet to a point on the South right of way of US Route 22; Thence along US Route 22 North 75°34'07" East 1045.37 feet to station 452+00/105S; Thence North 14°25'53" West across US Route 22 160.00 feet to a point station 452+00/55N on said right of way; Thence continuing along said right of way North 14°25'53" West 5.00 feet to a point station 452+00/60N; Thence along said right of way North 75°34'07" East 376.76 feet to a rail road spike set the place of beginning; Thence along the split lines of Raymond Wilkes Vol. , Page , the next three courses and distances, North 9°42'05" West 105.00 feet to a point passing an iron pin set at 104.50 feet; North 76°34'00" East 243.86 feet to an iron pin set, and South 27°04'29" East 102.89 feet to an iron pin set from which the Southeast Corner of Raymond Wilkes Jr. Vol. , Page , bears North 75°34'07" East 30.00 feet to an iron pin found; Thence along the North right of way of US Route 22 South 75°34'07" West 275.00 feet to the place of beginning containing 0.61 Acres more or less.

Bearings are based on the South Line of Section 2 bearing South 83°40'29" East.

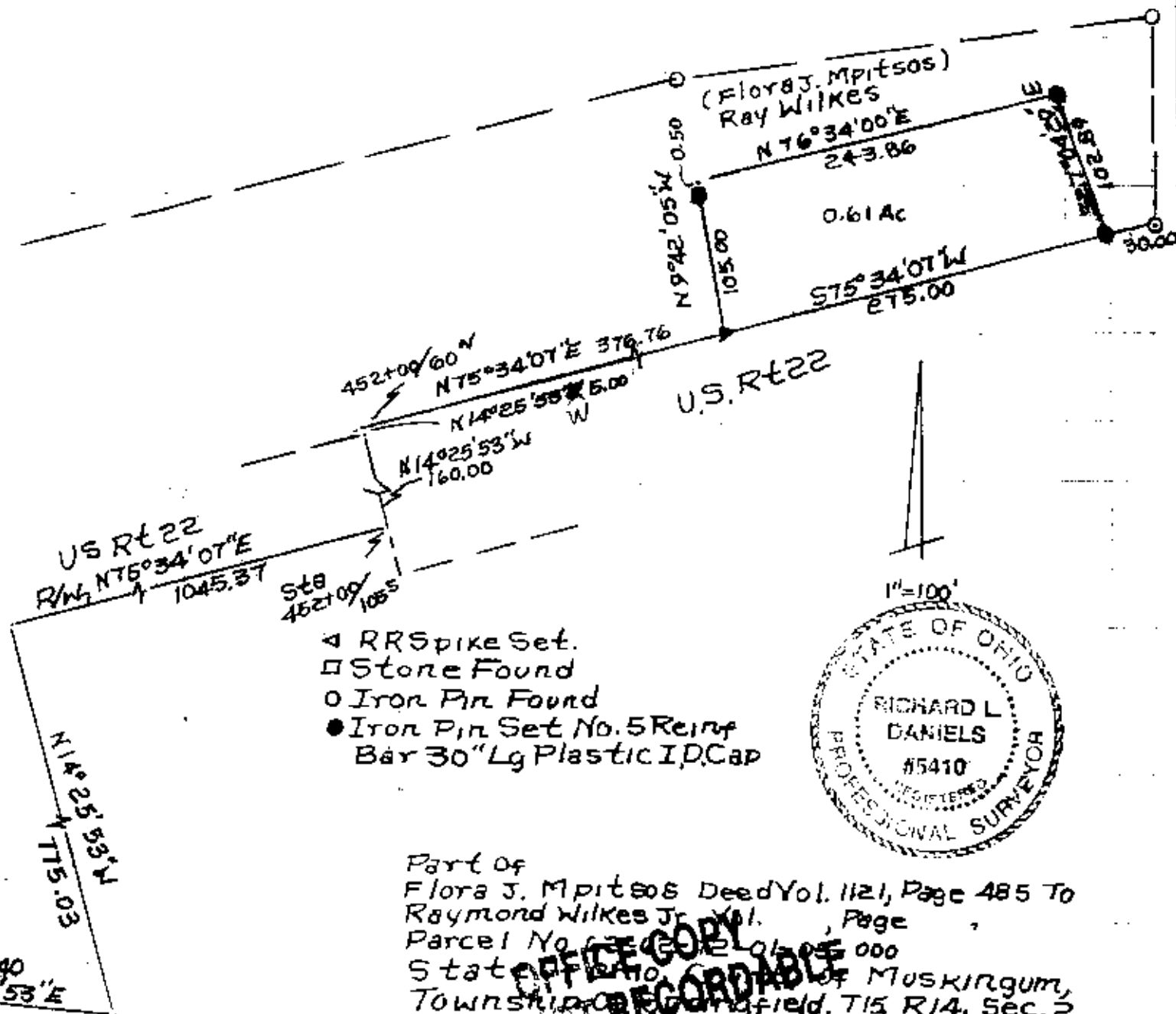
