COMMENCING AT THE NORTHWEST CORNER OF THE NORTHWEST QUARTER OF SECTION 5; THENCE ALONG THE NORTH LINE OF SAID SECTION SOUTH 87 DEGREES 26 MINUTES 00 SECONDS EAST 1775.54 FEET (BY DEED) TO THE EAST RIGHT-OF-WAY LINE OF THE CONRAIL RAILROAD; THENCE ALONG THE SAID EAST LINE SOUTH 10 DEGREES 33 MINUTES 00 SECONDS EAST 816.00 FEET (BY DEED) TO A POINT AT THE SOUTHWEST CORNER OF A TRACT CONVEYED TO N. L. GRAHAM AS RECORDED IN DEED VOLUME 1043, PAGE 221 OF THE MUSKINGUM COUNTY DEED RECORDS; THENCE LEAVING THE EAST LINE OF SAID RAILROAD AND ALSO LEAVING SAID GRAHAM TRACT AND THROUGH TRACTS CONVEYED TO D. AND R. BRILL (DEED VOLUME 1060, PAGE 113) AND T. D. GARRETT (DEED VOLUME 703, PAGE 338) SOUTH 20 DEGREES 58 MINUTES 00 SECONDS EAST 103.74 FEET TO AN EXISTING IRON PIN (1 INCH ROD) ON THE SOUTH LINE OF SAID GARRETT TRACT; THENCE ALONG SAID SOUTH LINE NORTH 79 DEGREES 24 MINUTES 02 SECONDS EAST 155.35 FEET TO A POINT ON THE LOW WATER MARK OF THE MUSKINGUM RIVER, PASSING AN EXISTING AXLE AT 139.85 FEET; THENCE LEAVING SAID GARRETT TRACT AND ALONG SAID LOW WATER MARK SOUTH 15 DEGREES 00 MINUTES 00 SECONDS EAST 438.95 FEET TO A POINT, SAID POINT BEING THE PLACE OF BEGINNING; THENCE CONTINUING ALONG THE LOW WATER MARK SOUTH 15 DEGREES 00 MINUTES 00 SECONDS EAST 69.00 FEET TO A POINT; THENCE SOUTH 73 DEGREES 17 MINUTES 13 SECONDS WEST 105.94 FEET TO A POINT, PASSING IRON PINS AT 10.08 FEET AND 72.55 FEET; THENCE NORTH 32 DEGREES 23 MINUTES 00 SECONDS WEST 69.00 FEET TO A POINT; THENCE NORTH 72 DEGREES 08 MINUTES 35 SECONDS EAST 126.66 FEET TO A PLACE OF BEGINNING, PASSING IRON PINS AT 28.93 FEET AND 114.88 FEET.

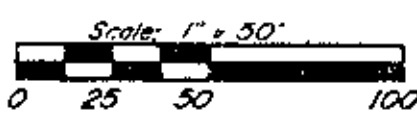
