Situated in the State of Ohio, County of Muskingum, Township of Springfield, being a part of the Northeast Quarter of Section 1, Township 15, Range 14, Congress Lands, and being a part of the property conveyed to Albert H. Kackley by Deed Volume 387, Page 307 of the Muskingum County Recorder's Office, and being more particularly described as follows:

Beginning for reference at an Axle found in the southerly line of Halley Drive (40') at the northeast corner of Lot 25 as the same is delineated on the plat of Southern Hills No. 2, as recorded in Plat Book 9, Page 22, thence North 01 degrees 26 minutes 00 seconds East, 40.00 feet to a point in the northerly line of said Halley Drive;

Thence along the northerly line of said Halley Drive and the southerly line of the properties conveyed to Charles Carmichael by Deed Volume 1088, Page 346 and Murial L. Osler by Deed Volume 669, Page 225, North 88 degrees 34 minutes 00 seconds West, 190.00 feet to the True Point of Beginning of the parcel herein to be described, said point being the southwesterly corner of said Carmichael property and the intersection of the northerly line of said Halley Drive with the projection of the easterly line of Albert Drive (40'), passing an iron pin set at 34.00 feet;

Thence continuing along the northerly line of said Halley Drive, North 88 degrees 34 minutes 00 seconds West, 40.00 feet to a Mag Nail set, said point being the intersection of the northerly line of said Halley Drive and the easterly line of Grandview Street (40');

Thence along the easterly line of said Grandview Street, North 01 degrees 24 minutes 27 seconds East, 59.67 feet to an Axle found at an angle point;

Thence continuing along said Grandview Street, North 62 degrees 50 minutes 02 seconds East, 133.71 feet to an Axle found at a point of curvature;

Thence continuing along said Grandview Street, along a tangent curve to the right with a radius of 168.57 feet, an arc length of 82.05 feet, a tangent length of 41.85 feet, a central angle of 27 degrees 53 minutes 12 seconds, a chord which bears North 76 degrees 46 minutes 38 seconds East, 81.24 feet to an iron pin set, said point being the northwesterly corner of said Osler property;

Thence along the westerly line of said Osler property, South 01 degrees 25 minutes 06 seconds West, 24.28 feet to an Axle found, said point being the northeasterly corner of said Carmichael property;

Thence along the northerly line of said Carmichael property, South 75 degrees 16 minutes 20 seconds West, 162.42 feet to an Axle found, said point being the northwesterly corner of said Carmichael property and on the projection of the easterly line of Albert Drive;

Thence along the westerly line of said Carmichael property and the projection of the easterly line of Albert Drive, South 01 degrees 24 minutes 27 seconds West, 74.74 feet to the True Point of Beginning, containing 0.146 Acres, 6,375 Square Feet, more or less. Subject to any and all easements, right-of-ways, conditions and restrictions of record. All iron pins set are 5/8-inch by 30-inch rebar with yellow identification caps labeled "Smart Surveying". Bearings shown herein are based upon the Southerly Right-of-Way line of Halley Drive being North 88 degrees 34 minutes 00 seconds West. This description was prepared by Smart Engineering & Surveying, Inc. in July 2000 and is based upon actual field measurements.

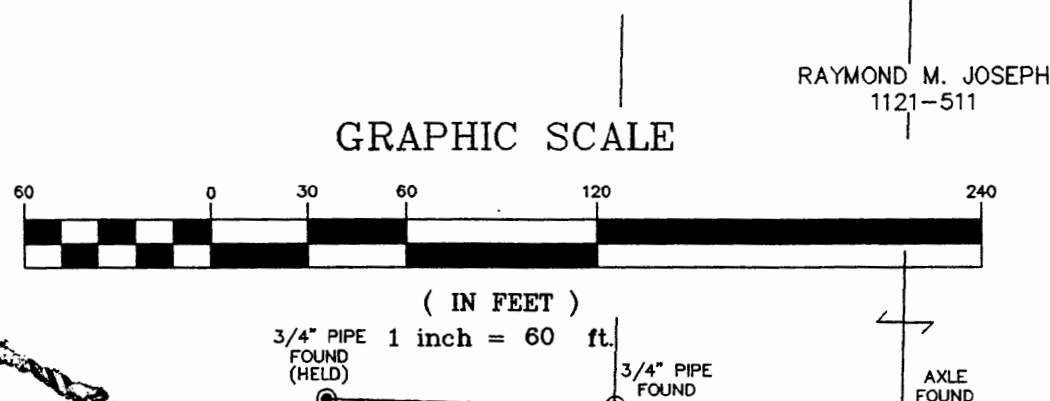

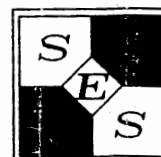
