

Adjoiner Split 3 of Donald L. and Frances C. Holdren in Springfield Township

Situated in the State of Ohio, County of Muskingum, Township of Springfield, and part of the Southwest Quarter of Section 5, Township 11, Range 13, Congress Lands East of the Scioto River, and being part of the lands presently owned by Donald L. and Frances C. Holdren as per Deed Record 1139-891, and being more particularly described as follows:

Beginning for reference at a iron pin set on the northwest corner of the Southwest Quarter of Section 5, Township 11, Range 13, Congress Lands East of the Scioto River;

Thence along the section line, South 02 degrees 50 minutes 51 seconds West, 163.80 feet to a point in the centerline of Grantcliff Road, (Twp. Rd. 467);

Thence along the centerline of said road, the following three courses:

- 1.) North 79 degrees 47 minutes 37 seconds East, 172.01 feet to a point;
- 2.) North 80 degrees 22 minutes 30 seconds East, 206.22 feet to a point;
- 3.) North 81 degrees 21 minutes 04 seconds East, 215.60 feet to a point on the northwest corner of lands presently owned by Donald L. and Frances C. Holdren, (DR 1139-891);

Thence along the west line of said Holdren lands, South 09 degrees 12 minutes 51 seconds East, 240.42 feet to an iron pin set on the principal place of beginning, passing an iron pin found at 18.56 feet;

Thence through said Holdren lands, the following two courses:

- 1.) North 84 degrees 27 minutes 35 seconds East, 170.09 feet to an iron pin set;
- 2.) South 84 degrees 18 minutes 33 seconds East, 36.02 feet to an iron pin set on the west line of lands presently owned by Randolph Clint Robert Neff, (OR 2466-385);

Thence along the west line of said Neff lands, South 09 degrees 19 minutes 40 seconds East, 40.77 feet to an iron pin set on the north line of lands presently owned by Neff Investments Ltd. of Ohio, (OR 2930-277);

Thence along the north line of said Neff Investments lands, South 84 degrees 04 minutes 25 seconds West, 204.91 feet to a point in a barn on the southwest corner of lands presently owned by Joseph G. and Teresa A. Neff, (DR 1042-253);

Thence along the east line of said Neff lands, North 09 degrees 16 minutes 15 seconds West, 49.18 feet to the principal place of beginning, containing 0.225 acres, more or less, and being part of Auditor's Parcel Number 62-82-01-01-003.

Note: The above described parcel is not to be used as a separate building site or transferred as an independent parcel in the future without planning commission approval in accordance with applicable subdivision regulations.

Subject to all legal recorded easements and right of ways.

Iron pins set are 5\8 inch rebars, 30 inches long, with plastic identification caps.

Bearings are based on the Ohio State Plane Coordinate System, NAD 83, South Zone, Grid North, as per G.P.S. observations.
