Thence along the south line of said Cannon lands, on a curve to the left with a delta angle of 19 degrees 16 minutes 18 seconds, an arc length of 254.36 feet, a radius of 756.78 feet, and a chord which bears South 78 degrees 02 minutes 43 seconds East, 253.35 feet to an iron pin found on the southwest corner of lands presently owned by Neff Investments Ltd. of Ohio, (OR 2930-277);

Thence along the south lines of said Neff Investments the following two courses:

- 2.) South 82 degrees 58 minutes 31 seconds East, 302.42 feet to an iron pin found;

Thence through the lands presently owned by National Gas and Oil Corporation, (DR 1045-39), South 83 degrees 21 minutes 24 seconds West, 801.53 feet to an iron pin set on the section line, and being the east line of lands presently owned by Wayne H. Miller, (OR 2823-191);

Thence along said section line and the east line of said Miller lands, and lands presently owned by Tracey L. and Charles F. Rucker Jr.(OR 2751-439), North 02 degrees 50 minutes 51 seconds East, 268.21 feet to the principal place of beginning, passing an iron pin found at 250.07 feet, containing 2.22 acres, more or less, and being part of Auditor's Parcel Number 62-82-01-03-000.
