SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, CITY OF SOUTH ZANESVILLE, AND BEING ALL OF LOT #407 OF SAID VILLAGE AS RECORDED IN PLAT BOOK 2, PAGES 95 AND 96, ALSO BEING LOTS 406 AND 408 NOW VACATED, AND BEING ALL THOSE LANDS INTENDED TO BE DESCRIBED IN DEED VOLUME 514, PAGE 561, PARCEL 1, PARCEL 2, AND PARCEL 3; BEING FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

BEGINNING AT AN IRON PIN SET AT THE SOUTHEAST CORNER OF FORMER LOT #406, SAID POINT ALSO BEING AT THE NORTHWEST CORNER OF EAST MAIN STREET AND WINDSOR STREET, THENCE, SOUTH 86 DEGREES - 30 MINUTES - 00 SECONDS WEST, 150.00 FEET TO A CONCRETE MONUMENT FOUND ON THE NORTH LINE OF SAID EAST MAIN STREET; THENCE, NORTH 03 DEGREES - 30 MINUTES - 00 SECONDS WEST, 132.00 FEET TO AN IRON PIN SET ON THE SOUTH LINE OF A 16 POOT ALLEY; THENCE, NORTH 86 DEGREES - 30 MINUTES - 00 SECONDS EAST, 150.00 FEET TO AN IRON PIN SET ON THE EAST LINE OF WINDSOR STREET; THENCE, SOUTH 03 DEGREES - 30 MINUTES - 00 SECONDS EAST, 132.00 FEET TO THE POINT OF BEGINNING, AND CONTAINING 0.455 ACRES MORE OR LESS.
