Beginning at an iron pin set at the northwest corner of said Lot 684, thence with the south line of Maysville Pike (U.S. 22), N 56°03'37" E a distance of 300.00 feet to an iron pin set at the northeast corner of Lot 679; thence with the east line of said Lot 679, S 33°56'23" E a distance of 120.00 feet to an iron pin set on the north line of an alley (16'); thence with the northern line of said alley, S 56°03'37" W a distance of 300.00 feet to a point at the southwest corner of said Lot 684, said point is referenced by a pipe found bearing, N 82°14'48" W a distance of 0.68 feet;

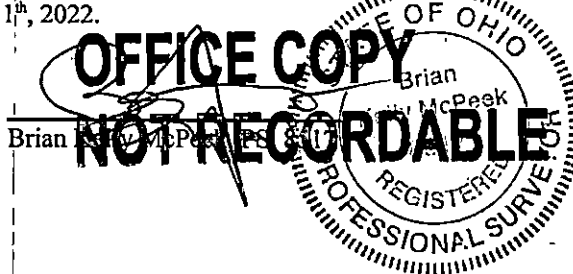
thence with the west line of said Lot 684, also being the east line of South Avenue (50'), N 33°56'23" W a distance of 120.00 feet to the place of beginning, containing a total of 0.8262 acres more or less, subject to all legal highways and easements of record.
