COMMENCING AT AN IRON PIN FOUND AT THE NORTHEAST CORNER OF THE NORTHEAST QUARTER OF SAID SECTION 3, THENCE, ALONG THE NORTH LINE THEREOF, NORTH 89 DEGREES - 04 MINUTES - 57 SECONDS WEST, 998.45 FEET TO A POINT ON THE SOUTH LINE OF HIGHLAND TOWNSHIP ROAD #187, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, SOUTH 00 DEGREES - 20 MINUTES - 42 SECONDS WEST, 233.24 FEET TO AN IRON PIN SET, PASSING AN IRON PIN SET AT 5.24 FEET; THENCE, NORTH 89 DEGREES - 39 MINUTES - 21 SECONDS WEST, 258.05 FEET TO AN IRON PIN FOUND AT THE SOUTHEAST CORNER OF THOSE LANDS DESCRIBED IN DEED VOLUME 1043, PAGE 239; THENCE, NORTH 00 DEGREES - 20 MINUTES - 38 SECONDS EAST, 235.46 FEET TO A POINT ON THE NORTH LINE OF SAID SECTION 3, PASSING IRON PINS FOUND AT 39.75 FEET AND 189.96 FEET; THENCE, SOUTH 89 DEGREES - 04 MINUTES - 57 SECONDS EAST, 258.06 FEET TO THE POINT OF BEGINNING, AND CONTAINING 1.388 ACRES MORE OR LESS.

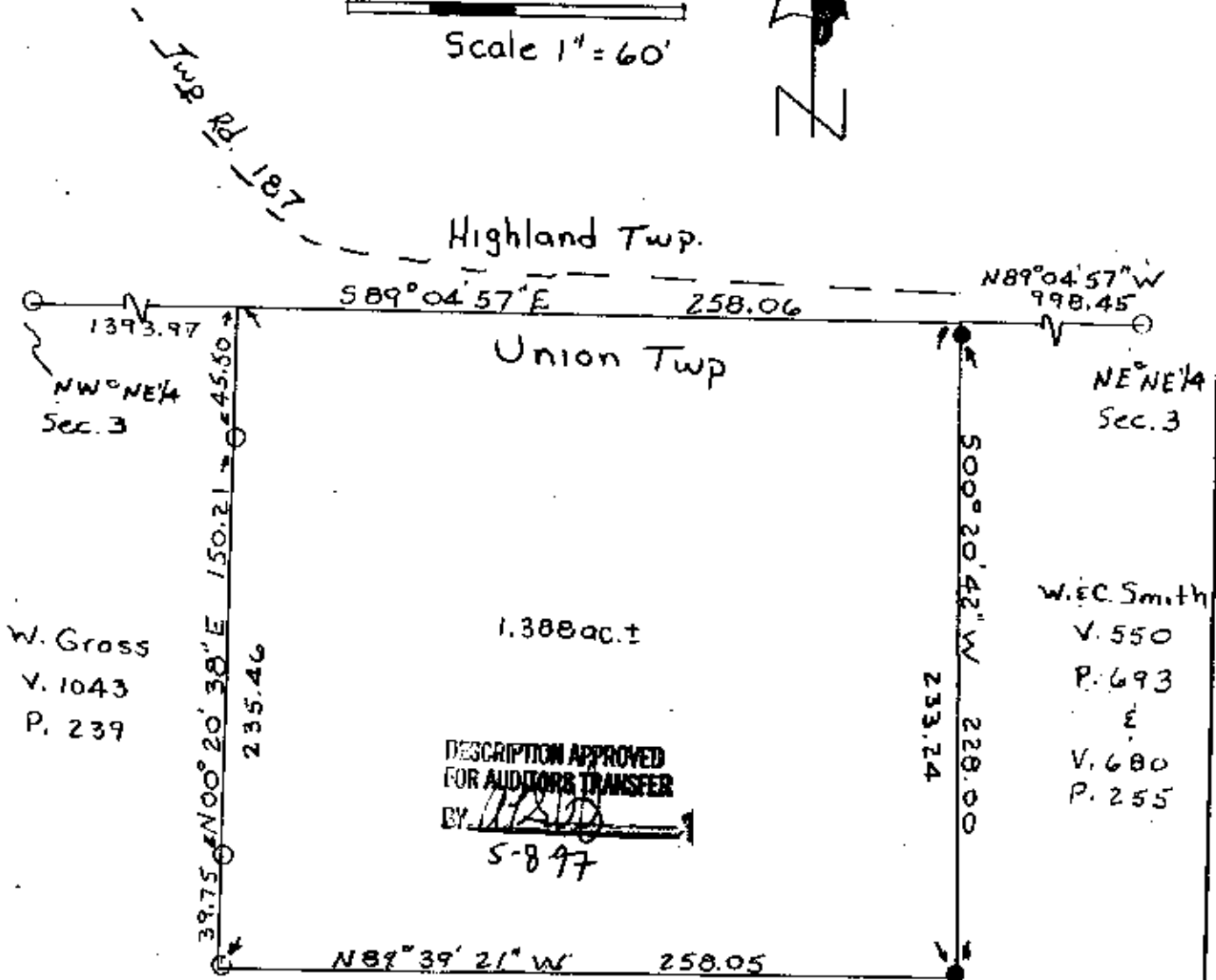
