Situated in the Northwest Quarter of Section 4, T-1-N, R-5-W, U.S.M.L., Union Township, Muskingum County, Ohio. Being part of the lands of B. Lowry, Et Al, conveyed in Deed Book 1740 Page 608 of the Muskingum County Deed Records, and being more particularly described as follows;

- Commencing at the Northeast corner of the Northwest Quarter of Section 4:  
Thence, **S.03°40'53"W.** a distance of **780.07 feet** along the East line of said quarter section to a found iron pin, **BEING THE POINT OF BEGINNING;**
- Thence, **S.03°40'53"W.** a distance of **300.00 feet** along the East line of said quarter section to a found iron pin;
- Thence, **N.85°16'10"W.** a distance of **605.71 feet** along the South line of the lands of B. Lowry, Et Al, (1740/608) to a set rebar;
- Thence, **N.03°40'54"E.** a distance of **251.05 feet** through said Lowry lands to a set rebar;
- Thence, **N.87°32'05"W.** a distance of **671.03 feet** through said Lowry lands to a point in the center of Lodge Road, passing a set rebar at 641.03';
- Thence, **N.00°17'26"W.** a distance of **25.03 feet** along said centerline to a point;
- Thence, **S.87°32'05"E.** a distance of **672.78 feet** along the North line of said Lowry lands to a set rebar, passing a found iron pin at 19.85 and 119.85 feet;
- Thence, **S.87°32'05"E.** a distance of **605.73 feet** along the North line of said Lowry lands to the point of beginning.

Commencing at the Northeast corner of the Northwest Quarter of Section 4; Thence, S.03°40'53"W. a distance of 1,080.07 feet along the East line of said quarter section to a found iron pin; Thence, N.85°16'10"W. a distance of 605.71 feet along the South line of the lands of B. Lowry, Et Al, (1740/608) to a set rebar, BEING THE POINT OF BEGINNING;

Thence, N.85°16'10"W. a distance of **655.67 feet** along the South line of the lands of B. Lowry, Et Al, (1740/608) to point in the center of Lodge Road, passing found iron pins at 525.67 and 625.67 feet;

Thence, N.00°05'45"E. a distance of **42.77 feet** along said centerline to a point;

Thence, N.00°17'26"W. a distance of **182.55 feet** along said centerline to a point;

Thence, S.87°32'05"E. a distance of **671.03 feet** through said Lowry lands to a set rebar, passing a set rebar at 30.00';

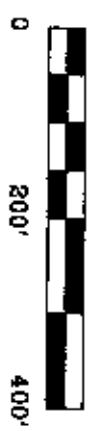

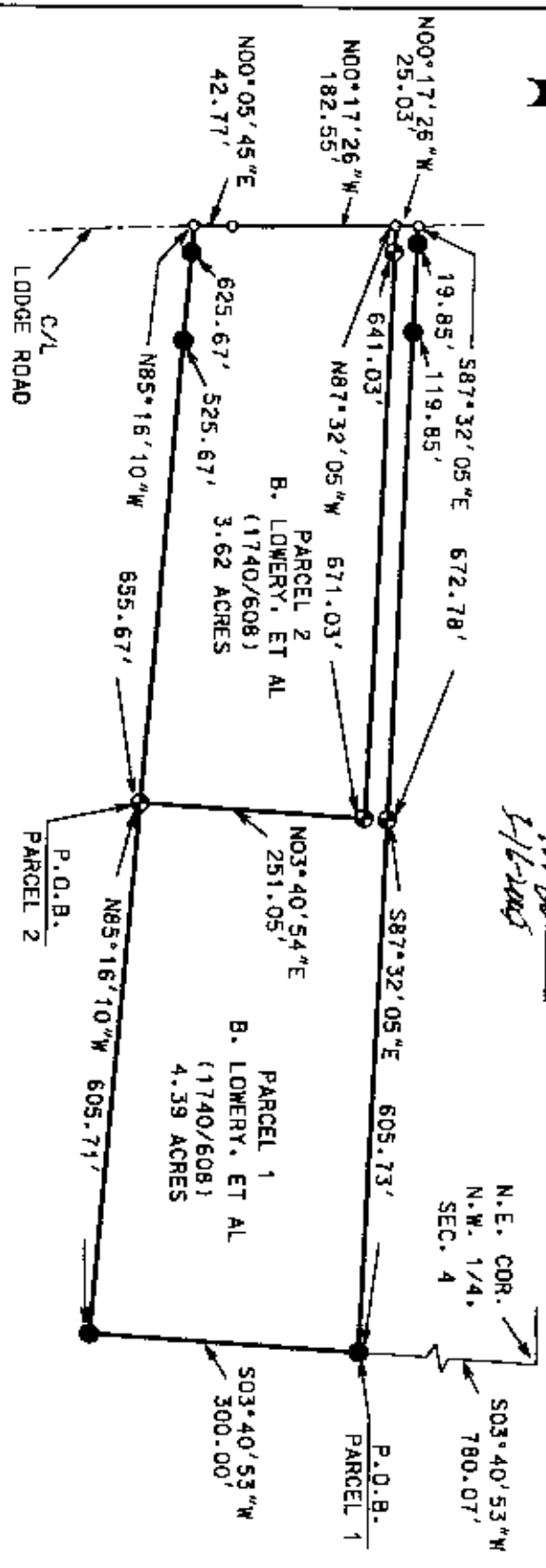
NORTH IS BASED UPON

MUSKINGUM COUNTY, OHIO.

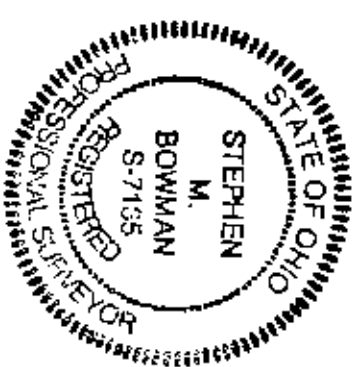
