Total 24.45 Acres

Situated in the Northeast Quarter of section 7, and the Northwest Quarter of Section 8, T-1, R-5, U.S.M.L., Union Township, Muskingum County, Ohio. Being part of the lands of Gerald De Palmo conveyed in deed book 1582 page 689 of the Muskingum County Deed records, and being described as follows:

Beginning at a found iron pin marking the Northwest corner of Lot 29 of Country Retreat, #3 (P.B. 16, Pg. 33);

- Thence, **N.83°54'18"W.** a distance of **805.27** feet along the South line of the Northeast Quarter of Section 7 to a found iron pin on the Southeast corner of the lands, now or formerly, owned by D. & J. Addy (1158/99);
- Thence, **N.01°32'55"W.** a distance of **452.11** feet along said Addy lands to a found iron pin;
- Thence, **N.31°04'23"W.** a distance of **164.08** feet along said Addy lands to a found iron pin, on the Southwest corner of the lands of M. Cooley (2152/033);
- Thence, **N.20°53'21"E.** a distance of **117.61** feet along said Cooley lands to a found iron pin;
- Thence, **N.33°46'30"W.** a distance of **105.66** feet along said Cooley lands to a found iron pin, on the Southwest corner of the lands of B. Hesson (2152/033);
- Thence, **N.55°54'22"E.** a distance of **117.78** feet along said Hesson lands to a found iron pin, on the Northwest corner of the lands of Muskingum County;
- Thence, **S.33°22'46"E.** a distance of **100.17** feet along said County lands to a found iron pin;
- Thence, **N.87°09'35"E.** a distance of **214.44** feet along the south line of the lands, now or formerly, owned by J. & W. Matheney, (1590/679) to a found iron pin;
- Thence, **S.82°45'32"E.** a distance of **400.35** feet along said Matheney lands to a found iron pin;
- Thence, **N.21°20'31"E.** a distance of **201.00** feet along said Matheney lands to a point in the center of T.R. 692, passing a found iron pin at 85.71' and a set rebar at 173.28';
- Thence, **N.87°34'08"E.** a distance of **307.32** feet along the center of said road to a point;
- Thence, **N.89°56'23"E.** a distance of **280.71** feet along the center of said road to a point;

- Thence, **S.02°22'12"W.** a distance of **296.47** feet along the lands, now or formerly, owned by E. Lazar (1038/490) to a found iron pin, passing a found iron pin at 32.63';
- Thence, **S.89°14'32"E.** a distance of **151.16** feet along said Lazar lands to a found iron pin on the West line of a 3.53 acre parcel;
- Thence, **S.02°06'51"W.** a distance of **207.71** feet along said 3.53 acre parcel to a set rebar;
- Thence, **S.87°15'25"E.** a distance of **575.74** feet along said 3.53 acre parcel to a point in the center of C.R. 468, passing a set rebar at 555.74';
- Thence, **S.05°33'23"E.** a distance of **35.54** feet along said road to a point;
- Thence, **S.03°04'31"W.** a distance of **34.72** feet along said road to a point;
- Thence, **N.87°16'13"W.** a distance of **1172.37** feet along the lands, now or formerly, owned by D. Hinderer (1835/879) to a found iron pin, passing a found iron pin at 21.23';
- Thence, **S.05°43'58"W.** a distance of **473.61** feet along said Henderer lands and the lands of E. Geyer (1079/293) to the point of beginning.

The above described parcel contains 24.45 acres, more or less, ( 0.65 acres in section 8 and 23.80 acres in section 7) and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.

Subject to an easement for ingress and egress from the East line of the Matheney property extending northeasterly to T.R. 692.

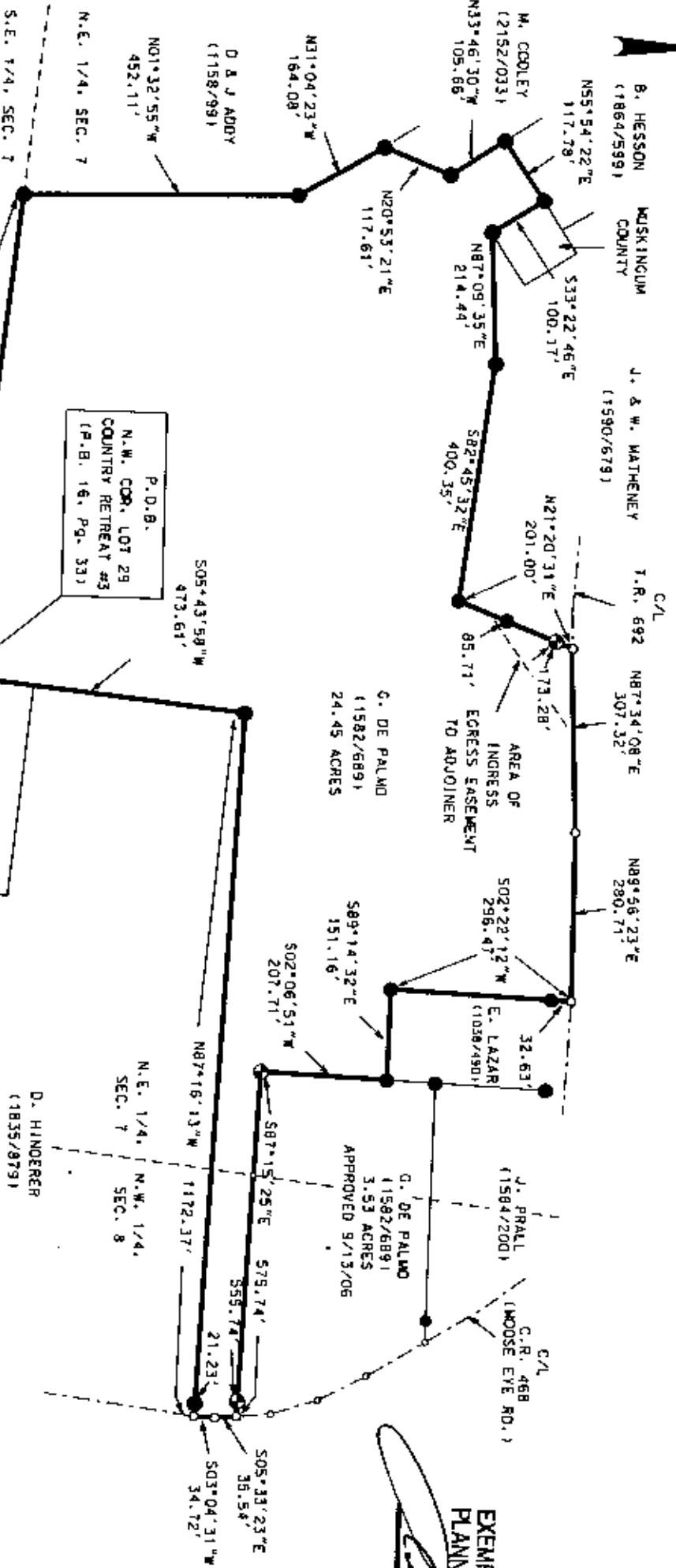
NORTH IS BASED UPON

24.45 ACRES



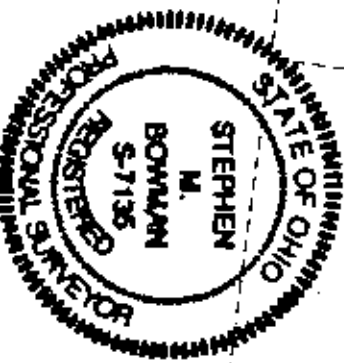
