SITUATED IN THE STATE OF OHIO, MUSKINGUM COUNTY, UNION TOWNSHIP, AND BEING PART OF THE SOUTHWEST QUARTER OF SECTION 8, TOWNSHIP 1, RANGE 5 OF THE UNITED STATES MILITARY LANDS, AND BEING ALL THOSE LANDS INTENDED TO BE DESCRIBED IN DEED VOLUME 1147, PAGE 163; BEING FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

COMMENCING AT A STONE AT THE NORTHWEST CORNER OF THE SOUTHWEST QUARTER OF SAID SECTION 8, THENCE, WITH THE NORTH LINE OF SAID SOUTHWEST QUARTER, SOUTH 83 DEGREES - 42 MINUTES - 54 SECONDS EAST, 1495.92 FEET TO A POINT IN THE CENTERLINE OF THE BALTIMORE AND OHIO RAILROAD; THENCE, LEAVING THE NORTH LINE OF SAID SOUTHWEST QUARTER AND WITH THE CENTERLINE OF SAID RAILROAD, SOUTH 42 DEGREES - 50 MINUTES - 00 SECONDS WEST, 827.81 FEET TO A NAIL MARKING THE T.S. STATION OF A CURVE TO THE RIGHT, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, CONTINUING ALONG SAID CURVE HAVING A RADIUS OF 1432.69 FEET, A LENGTH OF 426.03 FEET, THE CHORD OF WHICH BEARS SOUTH 47 DEGREES - 18 MINUTES - 00 SECONDS WEST, 424.68 FEET TO A POINT AT THE INTERSECTION OF SAID RAILROAD AND THE CENTERLINE OF COUNTY ROAD #436; THENCE, ALONG THE CENTERLINE OF SAID ROAD, NORTH 28 DEGREES - 07 MINUTES - 00 SECONDS WEST, 127.44 FEET TO A POINT; AND PASSING THROUGH THE RAILROAD RIGHT-OF-WAY AT 51.09 FEET; THENCE, CONTINUING ALONG THE CENTERLINE OF SAID COUNTY ROAD, NORTH 20 DEGREES - 02 MINUTES - 00 SECONDS WEST, 103.84 FEET TO A POINT; THENCE, LEAVING SAID ROAD, NORTH 64 DEGREES - 17 MINUTES - 50 SECONDS EAST, 235.75 FEET TO AN IRON PIN SET, PASSING THROUGH AN IRON PIN SET AT 12.43 FEET; THENCE, NORTH 87 DEGREES - 23 MINUTES - 40 SECONDS EAST, 156.49 FEET TO A POINT ON THE NORTH RIGHT-OF-WAY OF SAID RAILROAD; THENCE, SOUTH 51 DEGREES - 13 MINUTES - 38 SECONDS EAST, 50.00 FEET TO THE POINT OF BEGINNING, AND CONTAINING 1.5402 ACRES MORE OR LESS.
