Situated in the State of Ohio, County of Muskingum, Township of Union, Township 1, Range 5, part of the Southwest Quarter of Section 8, bounded and described as follows:

Commencing at the Southwest corner of Section 8; thence North  $1^{\circ} 46'$  West 113.59 feet to a point in the center of Interstate Route 70; thence along said center line on a curve to the right, having a radius of 5729.58 feet, the chord of which bears North  $74^{\circ} 31'$  East 1197.83 feet to a point; thence North  $80^{\circ} 31'$  East along Route 70 133.51 feet to the center of Moose Eye Road; thence along the center of Moose Eye Road North  $29^{\circ} 29'$  West 661.23 feet to a point; thence along center of Moose Eye Road North  $31^{\circ} 03'$  West 210.00 feet to a point; thence continuing along said road north  $23^{\circ} 26' 39''$  West 40.36 feet to a point; thence leaving Moose Eye Road South  $60^{\circ} 31'$  West 264.34 feet to an iron pin, the place of beginning; thence South  $60^{\circ} 31'$  West along a 40.00 foot wide right-of-way 145.44 feet to an iron pin found; thence north  $29^{\circ} 29'$  West 208.71 feet to an iron pin set on the North side of a creek; thence North  $60^{\circ} 31'$  East 145.44 feet to an iron pin set in said creek; thence South  $29^{\circ} 29'$  East 208.71 feet to the place of beginning, containing 0.70 acres more or less.

Also included is a right-of-way easement over a 40.00 foot wide road extending to Moose Eye Road.

Bearings are based on a survey by Peter Dinan, Deed Vol. 1052, Page 105.

Being a part of Auditor's Parcel Number 66-66-10-08-36-000.

Iron pins set are No. 5 reinforcing bars 30 inches long with plastic I. D. caps.

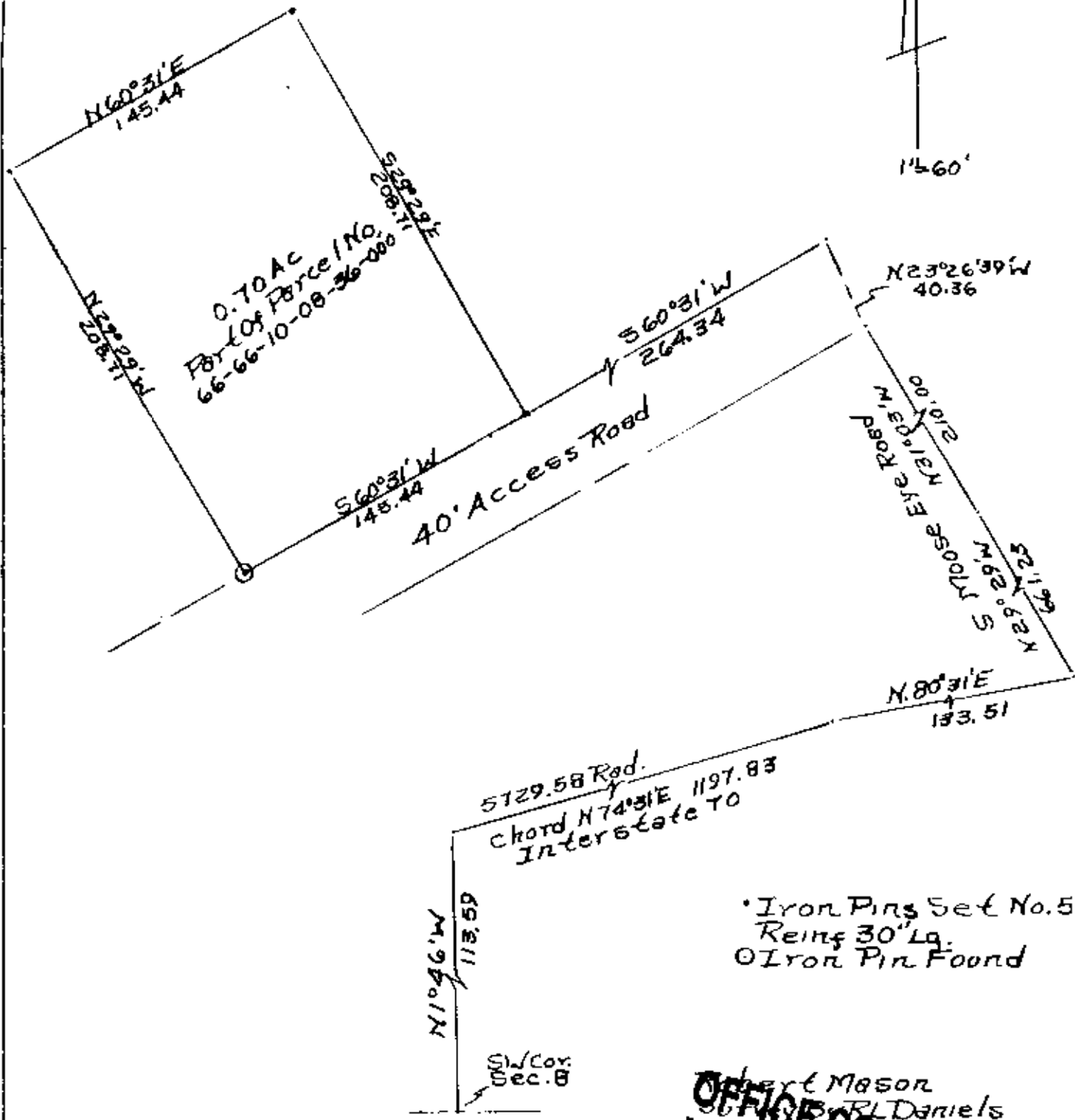
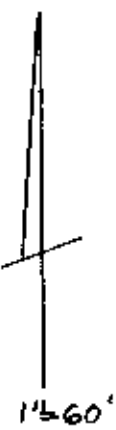
