

DEED DESCRIPTION FOR DANIEL E. & PATRICIA A. McFEE

Situate in the Township of Union, County of Muskingum, and State of Ohio, and being a parcel of land in the southeast quarter of Section 8, Township 1N, Range 5W of the "United States Military District" and being more particularly described as follows:

Commencing at an iron pin found at the southwest corner of the southeast quarter of Section 8, this being the TRUE POINT OF BEGINNING; thence N02°16'03"W with the land of Frederick D. and Charlene McFee as recorded in Deed Volume 627, Page 16 a distance of 187.83 feet to an iron pin found; thence with the south right-of-way line for Interstate Route 70 the following nine courses:

- [1] N75°51'49"E a distance of 50.14 feet to a point;
- [2] N85°43'15"E a distance of 326.37 feet to a point;
- [3] S49°16'07"E a distance of 78.21 feet to a point;
- [4] N83°20'02"E a distance of 300.37 feet to a point;
- [5] N22°02'40"E a distance of 47.75 feet to a point;
- [6] N85°43'22"E a distance of 225.95 feet to a point;
- [7] N71°56'37"E a distance of 498.68 feet to a point;
- [8] S80°35'38"E a distance of 250.80 feet to a point;
- [9] S65°50'24"E a distance of 194.10 feet to an iron pin set;

thence S03°06'39"E with the land of Charles W. and Patsy J. Tom as recorded in Deed Volume 729, Page 244 a distance of 224.42 feet to an iron pin found; thence S87°35'00"W with the south line of the southeast quarter of Section 8 a distance of 1880.00 feet to the point of beginning, containing 10.607 acres.

Subject to all leases, easements, rights-of-way, and restrictions of public records, if any.


