Tract I

Situated in the Township of Union, County of Muskingum, State of Ohio and being 15.886 acres in the northeast quarter of section 8 of Township 1 north Range 5 west of the United States Military District and being more particularly described as follows,

Commencing at a two inch iron pipe found at the northeast corner of the northeast quarter of said section 8 thence with the east line of said quarter S 01° 49' 24" W a distance of 842.41 feet to a point in a creek the **BEGINNING** thence continuing with said quarter line and with the lands of David L Green as recorded in deed volume 684 page 289 S 01° 49' 24" W a distance of 1202.27 feet to a point having passed through an iron pin set at 248.00 feet thence continuing with said quarter line and with the lands of David D. and Rose E. Wallace as recorded in deed volume 1146 page 28 S 01° 49' 24" W a distance of 97.92 feet to a point in the center of Homestead Drive thence with the center of said Homestead Drive and with a line through the lands of Leona M. Boyle as recorded in deed volume 736 page 39 N 57° 00' 00" W a distance of 50.00 feet to a point thence leaving said road and continuing through the lands of said Boyle the next three calls,

1) S 47° 30' 35" W a distance of 219.72 feet to a point in a creek having passed through an iron pin set at 40.00 feet.

2) N 88° 28' 41" W a distance of 944.08 feet to an iron pin set having passed through iron pins set at 8.00 feet and 588.75 feet.

3) N 15° 59' 49" W a distance of 507.07 feet to an iron pin set thence with the lands of Kay B. Hudson as recorded in deed volume 1068 page 542 the next five calls,

1) N 80° 14' 58" E a distance of 71.00 feet to a 5/8 inch capped rebar found.

2) S 40° 03' 31" E a distance of 301.22 feet to a 5/8 inch capped rebar found having passed through a 5/8 inch capped rebar found at 100.88 feet.

3) N 78° 54' 09" E a distance of 199.99 feet to a 5/8 inch capped rebar found having passed through a 5/8 inch capped rebar found at 150.00 feet.


4) N 78° 54' 09" E a distance of 578.93 feet to a point in Homestead Drive having passed through a 5/8 inch capped rebar found at 558.93 feet.

5) N 17° 20' 55" W a distance of 204.51 feet to a point thence with said road and with a line through the lands of Leona M. Boyle as recorded in deed volume 736 page 39 N 04° 54' 51" E a distance of 224.56 feet to a point in Homestead Drive thence continuing with said road and with the lands of Kay B. Hudson as recorded in deed volume 1068 page 542 the next two calls,

1) N 14° 42' 25" E a distance of 161.07 feet to a point in said road.

2) N 34° 06' 35" E a distance of 476.53 feet to a point in said road thence leaving said road and with the south line of the Railroad N 77° 36' 55" E a distance of 35.06 feet to the **BEGINNING** and containing 15.886 acres and being a part of the property conveyed in deed volume 736 page 39 and being a part of auditors parcel# 66-10-08-54.

Subject to all leases or easements of record. Iron pins set are 5/8 inch rebar, 30 inches long capped GARDNER PS-6884. Bearings are in degrees, minutes and seconds and are based on the grid meridian of the Ohio state plane south coordinate zone as determined by GPS observations.
