## DESCRIPTION OF 2.4780 ACRES EAST OF LODGE ROAD (COUNTY ROAD 21) NORTH OF NORWICH DRIVE UNION TOWNSHIP, MUSKINGUM COUNTY, OHIO

Situated in the State of Ohio, County of Muskingum, Union Township, Section 7, Township 1, Range 5 and being 2.4780 acres of land, 2.3111 acres of which is located in that 14.509 acre tract as described in a deed to Del Kevin Hughes and Marsha A. Hughes, of record in Deed Volume 1132, Page 708 (Auditor's Parcel No. 66-15-01-18-000) and 0.1669 acre is located in that 2.5265 acre tract as described in a deed to Kevin D. and Marsha Hughes, of record in Deed Volume 731, Page 39 (Auditor's Parcel No. 66-15-01-19-001), all references herein being to the records located at the Recorder's Office, Muskingum County, Ohio and being more particularly described as follows;

Beginning FOR REFERENCE at a 5/8" iron pin found at the Northwesterly corner of the Northeasterly Quarter of said Section 7, Thence North 89° 37' 47" East, along the northerly line of said Section 7, a distance of 25.74 feet to a point in the centerline of Lodge Road (County Road 21), said point also being the northwesterly corner of said 14.509 acre tract and the southwesterly corner of a 0.68 acre tract of land as described in a deed to Ricky William Neff, of record in Deed Volume 944, Page 22; Thence North 89° 37' 47" East, continuing along the northerly line of said Section 7, the northerly line of said 14.509 acre tract, a distance of 194.59 feet to an iron pin set and being the TRUE PLACE OF BEGINNING;

Thence North 89° 37' 47" East, continuing along the northerly line of said Section 7, the northerly line of said 14.509 acre tract, the southerly line of said 0.68 acre tract and the southerly line of a 10.7 acre tract as described in a deed to William and Joan Neff, of record in Deed Volume 623, Page 148, a distance of 273.98 feet to an iron pin set;

Thence South 00° 22' 13" East, through said 14.509 acre tract, with a new line of division, a distance of 267.64 feet to an iron pin set on the northerly line of said 2.5265 acre tract;

Thence South 29° 52' 06" West, through said 2.5265 acre tract, with a new line of division, a distance of 174.09 fect to an iron pin set on the westerly line of said 2.5265 acre tract;

Thence through said 14.509 acre tract, with new lines of division the following courses;

- 1. South 89° 37' 47" West, a distance of 186.30 feet to an iron pin set;
- North 00° 22' 13" West, a distance of 418.05 feet to the TRUE PLACE OF BEGINNING and containing 2.4780 acres of land.

## DESCRIPTION OF A PERPETUAL 50 FOOT WIDE INGRESS/EGRESS EASEMENT LOCATED ACROSS A 14.509 ACRE TRACT EAST OF LODGE ROAD (COUNTY ROAD 21) NORTH OF NORWICH DRIVE UNION TOWNSHIP, MUSKINGUM COUNTY, OHIO

Situated in the State of Ohio, County of Muskingurn, Union Township, Section 7, Township 1, Range 5 and being located in that 14.509 acre tract of land as described in a deed to Del Kevin Hughes and Marsha A. Hughes, of record in Deed Volume 1132, Page 708, all references herein being to the records located at the Recorder's Office, Muskingum County, Ohio and being more particularly described as follows;

Beginning FOR REFERENCE at a point in the centerline of Lodge Road (County Road 21), being a point on the northerly line of the northeasterly quarter of Section 7 and the northwesterly corner of said 14.509 acre tract and bearing North 89° 37' 47" East, a distance of 25.74 feet from the northwesterly corner of the northeasterly quarter of said Section 7; Thence North 89° 37' 47" East, along the northerly line of said Section 7 and the northerly line of said 14.509 acre tract, a distance of 194.59 feet to an iron pin at the northwesterly corner of a new 2.4780 acre tract of land of which benefits from this ingress/egress easement; Thence South 00° 22' 13" East, along the westerly line of said 2.4780 acre tract, a distance of 418.05 feet to an iron pin and the TRUE PLACE OF BEGINNING;

Thence North 89° 37' 47" East, along the southerly line of said 2.4780 acre tract, a distance of 87.27 feet to a point;

Thence through said 14.509 acre tract the following courses;

- South 54° 40' 30" West, a distance of 234.19 feet to a point on the easterly right-of-way line of said Lodge Road (40 feet in width - AKA Co. Rd. 21);
- 2. North 13° 13' 14" West, along said right-of-way line, a distance of 17.64 feet to a point;
- North 33° 08' 01" West, continuing along said right-of-way line, a distance of 33.68 feet to a point;

Thence North 54° 40' 30" East, a distance of 154.73 feet to the TRUE PLACE OF BEGINNING;
