Commencing at an iron pin set at the southeast corner of said southwest quarter of section 7; thence north 86 degrees 30 minutes west along the south line of said quarter section 182.00 feet to a point, said point bears north 32 degrees 58 minutes 06 seconds west 4.00 feet from an existing axle; thence north 32 degrees 58 minutes 06 seconds west 108.01 feet to an existing axle; thence north 15 degrees 07 minutes 36 seconds west 5.25 feet to an iron pin set at the true place of beginning for the following described parcel; thence continuing north 15 degrees 07 minutes 36 seconds west 33.51 feet to an iron pin set; thence south 61 degrees 15 minutes west (the base of bearings used for this description) along the north line of a 0.61 acre parcel owned by Chester and Mary Grace West (Deed Book 455, Page 544) a distance of 167.66 feet to an existing axle and passing through an existing axle at 9.00 feet; thence north 30 degrees 00 minutes west 120.70 feet to an iron pin set; thence north 50 degrees 13 minutes 05 seconds east 405.90 feet to a point in the center of Sundale Road and passing through an existing axle at 380.27 feet; thence south 4 degrees 28 minutes 06 seconds east along the center of said road 235.71 feet to a point; thence south 54 degrees 39 minutes 50 seconds west 140.00 feet to the true place of beginning and passing through an existing axle at 26.57 feet containing one and three hundred twenty eight thousandths (1.328) acres

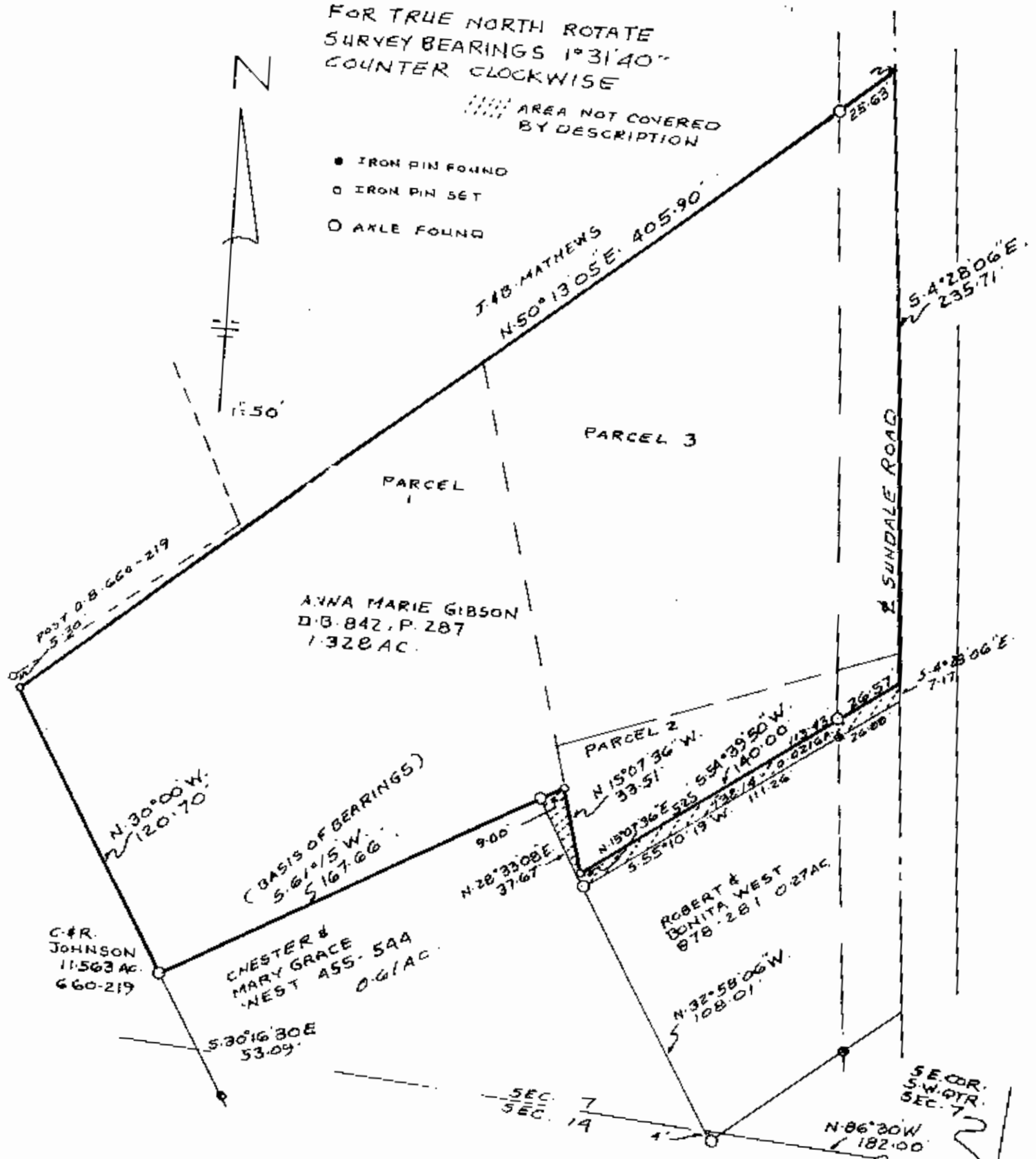
