Bearings are magnetic and are for angle purposes only.

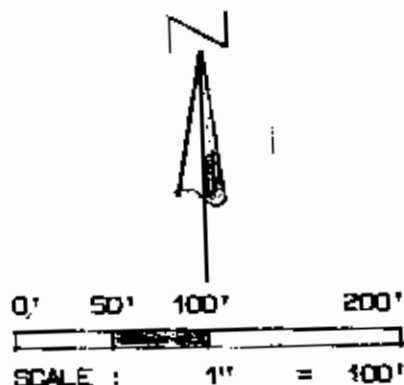

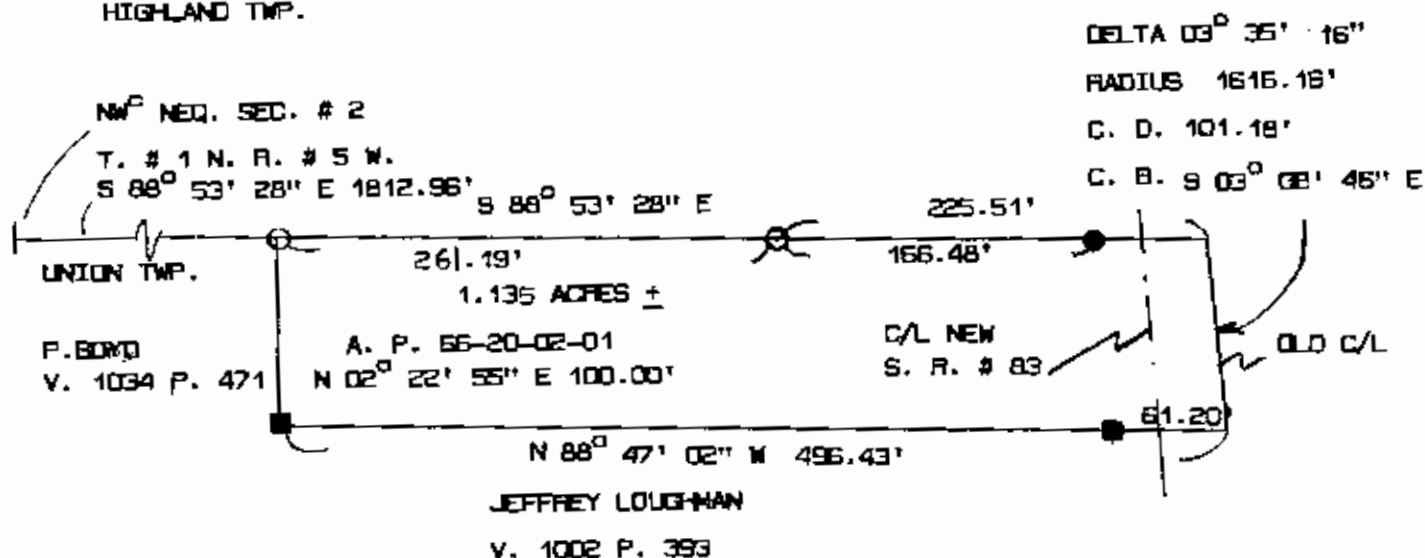
