

DEED DESCRIPTION FOR JOSEPH B. ELKINS

Situate in the Township of Union, County of Muskingum, and State of Ohio, and being a parcel of land in the northeast quarter of Section 2, Township 1N, Range 5W of the "United States Military District" and being more particularly described as follows:

Commencing at the southeast corner of the northeast quarter of Section 2, thence N89°17'53"W with the south line of said northeast quarter a record distance of 500.00 feet to an iron pipe found; thence N05°32'50"E with the land of Anna Rankin as recorded in Deed Volume 816, Page 175 a distance of 104.76 feet to an iron pin found, this being the TRUE POINT OF BEGINNING; thence with the land of said Anna Rankin the following three courses:

[1] N04°55'29"E a distance of 134.25 feet to an iron pin found;
[2] N04°36'22"E a distance of 137.47 feet to an iron pin set;
[3] N60°58'50"E a distance of 48.94 feet to an iron pipe found;
Thence N59°59'58"E with the land of Betty McKahan as recorded in Deed Volume 1091, Page 571 a distance of 170.44 feet to an iron pipe found; thence N87°55'55"E with the land of Robert J. and Cindy A. Lawton as recorded in Deed Volume 1083, Page 438 a distance of 209.73 feet to a point in the center of State Route 83 (passing on line an iron pipe found at a distance of 190.63 feet); thence S19°17'12"E with the center of State Route 83 a distance of 32.20 feet to a point; thence with the land of M. and T. McCabe as recorded in Deed Volume 1145, Page 821 the following three courses:

[1] S86°38'09"W a distance of 138.66 feet to an iron pin found (passing on line an iron pin found at a distance of 24.40 feet);
[2] S35°37'50"W a distance of 276.52 feet to an iron pin found;
[3] S29°02'09"W a distance of 132.26 feet to an iron pin found;
Thence S83°06'56"W with the land of New Concord Cemetery as recorded in Deed Volume 1142, Page 165 a distance of 70.00 feet to the point of beginning, containing 1.326 acres, being all of the land conveyed to Joe B. Elkins as recorded in Deed Volume 622, Page 116 and all of the land conveyed to Joseph Elkins as recorded in Deed Volume 1152, Page 583.

Subject to the right-of-way for State Route 83.

Subject to all leases, easements, rights-of-way, and restrictions of public records, if any.

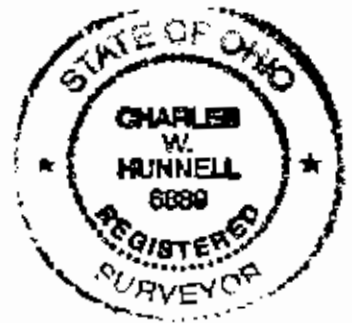

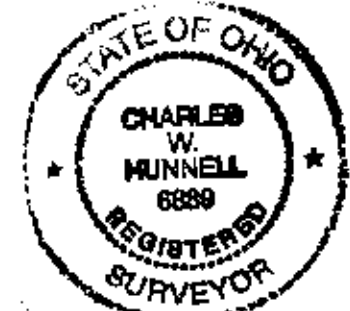
