COMMENCING AT THE NORTHWEST CORNER OF SECTION 2; THENCE SOUTH 00 DEGREES 22 MINUTES 58 SECONDS WEST 1447.04 FEET (BY DEED) ALONG THE WEST LINE OF SECTION 2 TO A POINT AT THE SOUTHWEST CORNER OF A 8.013 MORE OR LESS ACRE TRACT; THENCE SOUTH 88 DEGREES 54 MINUTES 32 SECONDS EAST 866.76 FEET ALONG THE SOUTH LINE OF SAID TRACT TO AN IRON PIN SET IN THE CENTER OF A RAVINE, SAID IRON PIN BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED; THENCE CONTINUING SOUTH 88 DEGREES 54 MINUTES 32 SECONDS EAST 254.11 FEET ALONG SAID TRACT TO A POINT IN THE CENTER OF TOWNSHIP ROAD 187, PASSING AN EXISTING IRON PIN (3/4 INCH PIPE) AT 229.11 FEET; THENCE SOUTH 17 DEGREES 15 MINUTES 08 SECONDS EAST 169.98 FEET TO A POINT IN THE CENTER OF SAID ROAD; THENCE SOUTH 79 DEGREES 47 MINUTES 43 SECONDS WEST 338.25 FEET TO AN IRON PIN SET IN THE CENTER OF THE ABOVE MENTIONED RAVINE, PASSING IRON PINS SET AT 16.72 FEET AND 265.86 FEET; THENCE NORTH 07 DEGREES 08 MINUTES 05 SECONDS EAST 228.87 FEET ALONG SAID RAVINE TO THE PLACE OF BEGINNING.

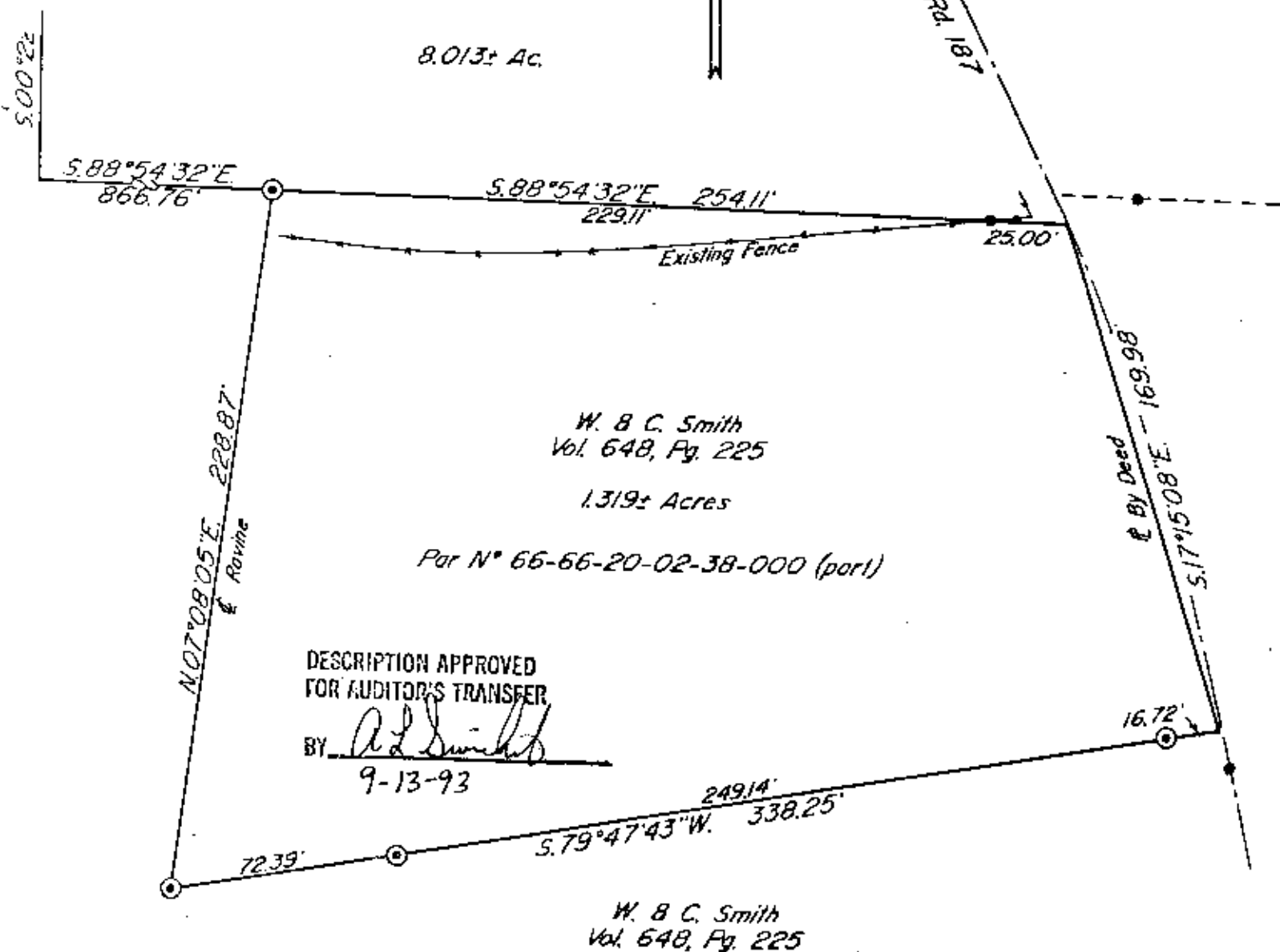
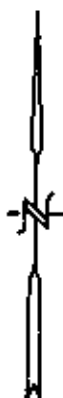
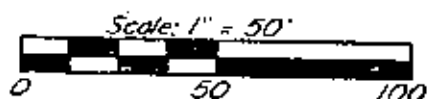
