SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF UNION, AND BEING PART OF THE NORTHWEST QUARTER OF SECTION 2, TOWNSHIP 1, RANGE 5, AND BEING PART OF THOSE LANDS INTENDED TO BE DESCRIBED IN DEED VOLUME 648, PAGE 225; BEING FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

COMMENCING AT A STONE FOUND AT THE SOUTHEAST CORNER OF THE NORTHWEST QUARTER OF SAID SECTION 2, THENCE, NORTH 89 DEGREES - 34 MINUTES - 51 SECONDS WEST, 942.53 FEET TO A POINT IN THE CENTER OF TOWNSHIP ROAD #187, PASSING AN IRON PIN FOUND AT 912.53 FEET, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, CONTINUING NORTH 89 DEGREES - 34 MINUTES - 51 SECONDS WEST, 548.87 FEET TO AN IRON PIN SET, PASSING AN IRON PIN FOUND AT 20.95 FEET; THENCE, NORTH 23 DEGREES - 41 MINUTES - 03 SECONDS WEST, 70.92 FEET TO A POINT IN THE CENTERLINE OF A FIFTY (50) FOOT WIDE INGRESS/EGRESS EASEMENT, PASSING AN IRON PIN SET AT 43.84 FEET; THENCE, NORTH 43 DEGREES - 42 MINUTES - 47 SECONDS EAST, 248.54 FEET ALONG SAID EASEMENT TO AN IRON PIN FOUND; THENCE, CONTINUING ALONG THE CENTERLINE OF SAID EASEMENT, NORTH 26 DEGREES - 28 MINUTES - 38 SECONDS EAST, 241.26 FEET TO A POINT; THENCE, LEAVING SAID EASEMENT, SOUTH 32 DEGREES - 40 MINUTES - 51 SECONDS EAST, 551.94 FEET TO THE POINT OF BEGINNING, PASSING IRON PINS SET AT 29.12 FEET AND 417.80 FEET, AND CONTAINING 3.0466 ACRES MORE OR LESS.

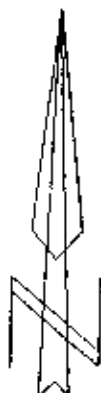
