

DESCRIPTION OF 0.3943 ACRE

Situated in the State of Ohio, County of Muskingum, Township of Union, being in the southeast quarter of Section 10, Range 5 West, Township 1 North, of "The United States Military Lands", being a new survey of a residue part of the land conveyed to Isaac Storer by Deed Volume 30, Page 469 of the Muskingum County Recorder's Office, and being bounded and described as follows:

Commencing for Reference at a concrete monument found at the center of Section 10 (Note: Reference bearing on the west line of the northeast quarter of Section 10 used as South 05°07'14" West.);

Thence, with the quarter section line, South 84°24'27" East a distance of 1,023.04 feet to a 5/8" iron pin found capped "Spilker 5862" at the northwest corner of an original 7.10 acres tract described in Deed Volume 240, Page 16 of the Muskingum County Recorder's Office, said iron pin being being THE TRUE POINT OF BEGINNING for this description;

Thence, from said Point of Beginning and running with the west line of an original 7.10 acres tract as conveyed to George Messerschmidt by Deed Volume 240, Page 16 and the west line of a 1.674 acres tract as conveyed to Stradford Real Estate Rental and Development Co. by Official Records Volume 1991, Page 706 of the Muskingum County Recorder's Office, South 34°10'03" West a distance of 415.03 feet to a 5/8" iron pin found uncapped in the east right-of-way line of State Route No. 83 (Friendship Drive) (formerly State Route 76);

Thence, with the east right-of-way line of State Route No. 83, North 27°21'47" West a distance of 26.89 feet to a point in the south right-of-way line of Township Road No. 65 (Liberty Road);

Thence, with the south right-of-way line of Township Road No. 65 (Deed Volume 532, Page 547), the following four courses:

- 1. North 18°25'17" East a distance of 81.18 feet to a point;
- 2. Thence North 26°46'09" East a distance of 67.19 feet to a point;
- 3. Thence North 38°52'00" East a distance of 209.40 feet to a point;
- 4. Thence North 32°08'42" East a distance of 27.47 feet to a point;

Thence South 85°01'35" East a distance of 43.68 feet to The Point of Beginning;

Containing 0.3943 acre, more or less, being a new survey of all of Auditor's Parcel No. 66-66-20-10-04-000.

Subject to all legal right-of-ways, easement, restrictions, reservations, and zoning regulations of record.

Subject to the 100-Year Flood Plain restrictions, if applicable.

All iron pins set are 5/8" x 30" rebar capped and labeled "Claus 6456".

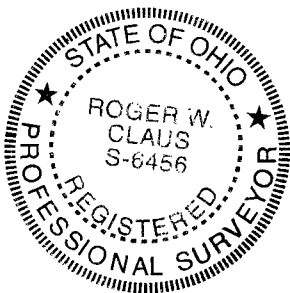

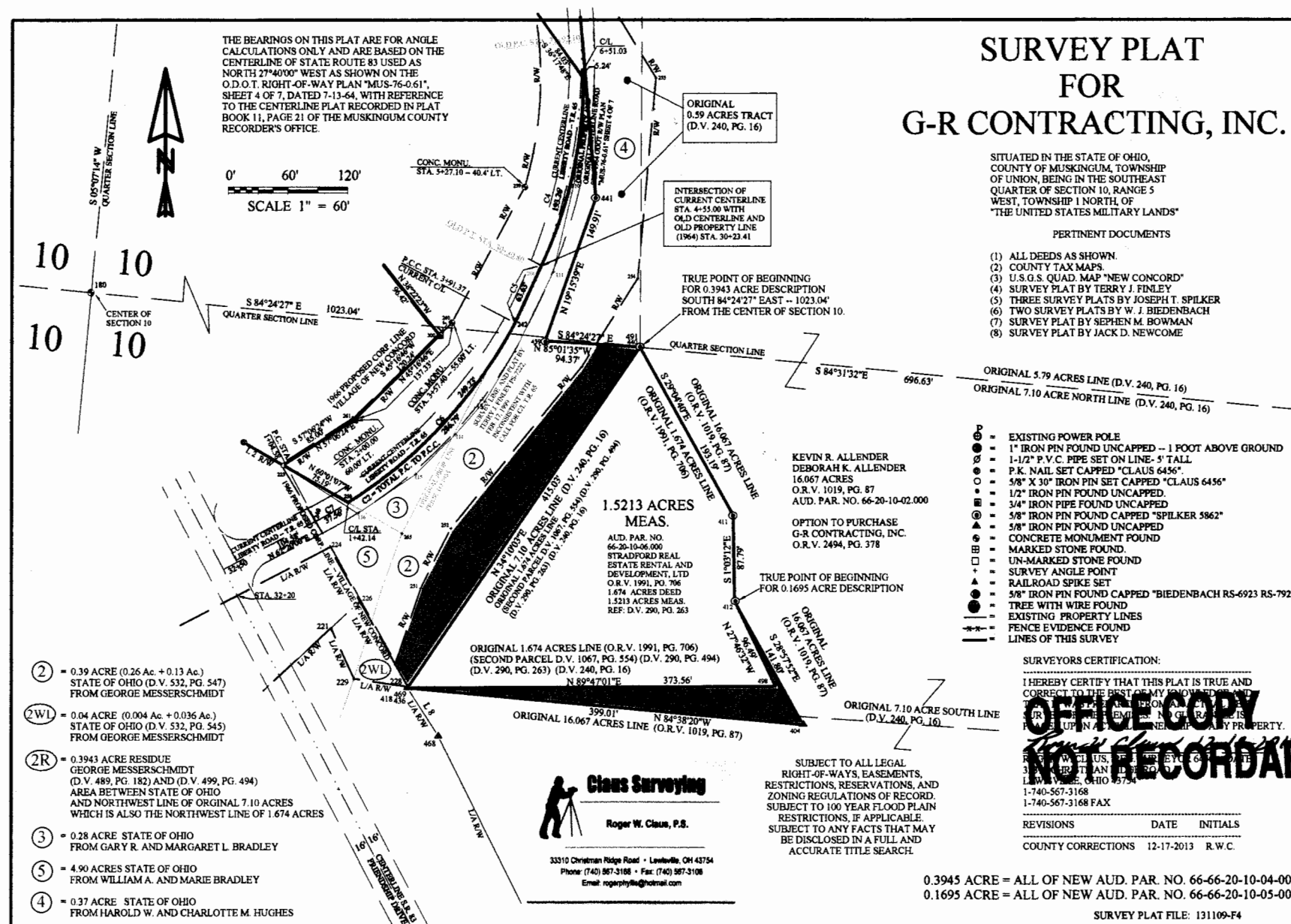

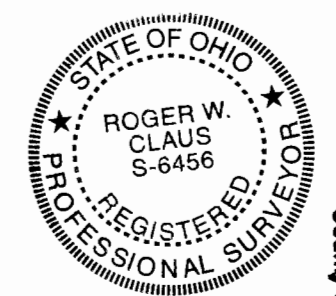
