1) Thence, along the Section line S 89° 40' 24" E 230.41 feet to an iron pin found;
2) N 00° 16' 48" W 364.82 feet to an iron pin found;
3) N 54° 51' 18" W 69.75 feet to an iron pin found;
4) N 24° 07' 41" W 163.91 feet to an iron pin found;
5) N 87° 52' 33" E 258.24 feet to an iron pin found;
6) N 04° 16' 37" W 291.05 feet to an iron pin found;
7) N 88° 44' 51" E passing a reference iron pin found at 609.45 feet a total distance of 639.45 to a point in the centerline of Sunflower Drive (Co. Rd. 65) said point being located at centerline Station 15+54.97 feet, the PRINCIPAL PLACE of BEGINNING of the 4.908 acre parcel herein to be described;

Thence, along the centerline of Sunflower Drive (Co. Rd. 65) and the West line of lands conveyed to W. and D. Adams, Deed Volume 1147 page 278 N 52° 44' 18" W 284.70 feet to a point in said centerline;

Thence, leaving said centerline and along the South line of lands conveyed to J. Dickerson, Deed Volume 1047 page 278 N 85° 36' 20" E 611.65 feet to an iron pin found;

Thence, along the West line of Limited Access State Route 83 S 40° 30' 24" E 355.37 feet to a point;

Thence, N 52° 29' 10" E 65.00 feet to a point in the centerline of State Route 83;

Thence, along the centerline of State Route 83 S 37° 30' 50" E 60.00 feet to a point;

Thence, leaving said centerline along the lands of Organic Waste Tech. Inc., Deed Volume 1131 page 473 S 52° 29' 10" W 100.01 feet to an iron pin set;

Thence, continuing along the lands of Organic Waste Tech Inc. and with what represent new lines through the Teague parcel the following Three (3) courses and distances,

- 1) with a curve to the Right having a Radius of 381.97 feet and a Chord Bearing S 89° 51' 59" W 463.79 feet to a point;
- 2) N 52° 45' 12" W 183.89 feet to a point;
- 3) N 52° 44' 18" W 15.94 feet to the PRINCIPAL PLACE of BEGINNING.

Said parcel as surveyed contains 4.908 acres more or less and is subject to the right of ways of Neptune Lane, State Route 83, and Sunflower Drive and all other right of ways, restrictions and easements of record.

Bearings of the above description are based on the North line of Section 11 the same being the South line of Section 10, Twp.-1N, Rng 5W, Union Township as being S 89° 40' 24" E and are used to denote angles only.


Note: all Deed Volumes and Official Records and pages referenced to above are found in the office of the Recorder, Muskingum County, Ohio.
