COMMENCING AT THE SOUTHEAST CORNER OF THE SOUTHWEST QUARTER OF SECTION 2, THENCE, NORTH 09 DEGREES - 49 MINUTES - 00 SECONDS EAST, 779.39 FEET TO A POINT; THENCE, NORTH 08 DEGREES - 42 MINUTES - 20 SECONDS EAST, 160.88 FEET TO A POINT; THENCE, NORTH 08 DEGREES - 02 MINUTES - 15 SECONDS EAST, 229.87 FEET TO A POINT; THENCE, NORTH 06 DEGREES - 44 MINUTES - 00 SECONDS EAST, 201.00 FEET TO A POINT; THENCE, NORTH 06 DEGREES - 20 MINUTES - 56 SECONDS EAST, 92.44 FEET TO A POINT; THENCE, NORTH 08 DEGREES - 15 MINUTES - 11 SECONDS WEST, 68.05 FEET TO A POINT; THENCE, NORTH 26 DEGREES - 17 MINUTES - 51 SECONDS WEST, 86.38 FEET TO A POINT; THENCE, NORTH 33 DEGREES - 32 MINUTES - 48 SECONDS WEST, 38.43 FEET TO A POINT IN THE CENTERLINE OF MAPLEBROOK ROAD, THENCE, NORTH 32 DEGREES - 45 MINUTES - 37 SECONDS WEST, 290.81 FEET TO A POINT IN CENTER OF SAID ROAD, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, SOUTH 47 DEGREES - 38 MINUTES - 45 SECONDS WEST, 312.72 FEET TO A POINT, PASSING IRON PINS SET AT 20.00 FEET AND 258.72 FEET; THENCE, NORTH 34 DEGREES - 53 MINUTES - 35 SECONDS WEST, 141.26 FEET TO A POINT; THENCE, NORTH 47 DEGREES - 46 MINUTES - 48 SECONDS EAST, 317.92 FEET TO A POINT IN THE CENTERLINE OF SAID MAPLEBROOK ROAD, PASSING AN IRON PIN SET AT 93.50 FEET; THENCE, SOUTH 32 DEGREES - 45 MINUTES - 37 SECONDS EAST, 141.29 FEET TO THE POINT OF BEGINNING, AND CONTAINING 1.011 ACRES MORE OR LESS.

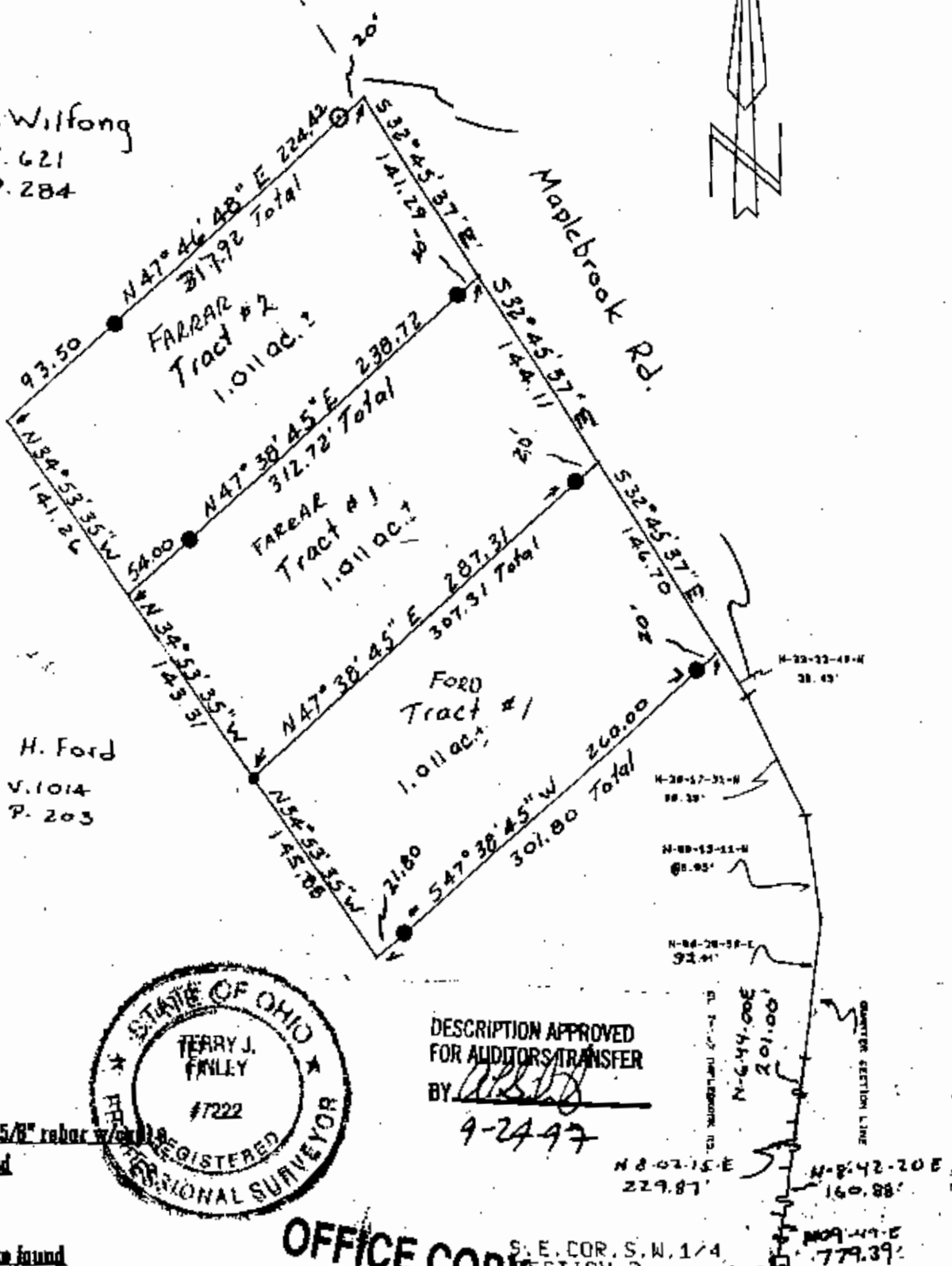
