

DESCRIPTION OF PART OF PARCEL, # 66 - 23 - 01 - 55 WHICH WAS TRANSFERRED TO WILLIAM L. AND CATHERINE SUE MARSHALL IN VOLUME 1125 PG. 585 OF MUSKINGUM COUNTY RECORDS.

Situate in the State of Ohio, County of Muskingum, Township of Union, and being a part of the Northwest Quarter of Section #9, Township 1 North, Range 5 West, in the United States Military District and being a part of parcel #66 - 23 - 0t - 55 as conveyed to William L. And Catherine A. Marshall, in Deed Volume 1125, Page 585 of the Muskingum County Deed Records, and being more particularly bounded and described as follows:
