LEGAL DESCRIPTION

Situated in the State of Ohio, County of Muskingum, Township of Union, and being part of the northeast and southeast quarters of Section 2, Township 1, Range 5, and being part of those lands intended to be described in Deed Volume 1142, page 165 and Deed Volume 203, page 490; being further bounded and described as follows:

Commencing at a stone found at the southeast corner of the northeast quarter of said Section 2, thence, north 87 degrees – 26 minutes – 11 seconds west, 390.87 feet to a point on the Quarter Section line, and the **true point of beginning** for the parcel herein intended to be described;

Thence, with a new division line through the lands now owned by The New Concord Cemetery Association (203/490), the following two (2) courses and distances:

1. South 05 degrees – 18 minutes – 56 seconds west, 65.14 feet to an iron pin set;
2. South 49 degrees – 27 minutes – 09 seconds west, 86.99 feet to an iron pin found;

Thence, along the easterly line of those lands now or formerly owned by Justin Sawyer (2251/190), north 19 degrees – 37 minutes – 41 seconds west, 134.50 feet to an iron pin found;

Thence, south 87 degrees – 25 minutes – 26 seconds east, along aforesaid quarter section line and the southerly line of those lands now or formerly owned by A.M. Rankin (816/175), 8.75 feet to a point;

Thence, north 05 degrees – 33 minutes – 15 seconds east, 106.85 feet, along the east line thereof, to an iron pin found;

Thence, north 83 degrees – 44 minutes – 33 seconds east, 70.00 feet, along the southerly line of those lands now or formerly owned by A.L. Cochran (2057/131), to an iron pin found;

Thence, continuing north 83 degrees – 44 minutes – 33 seconds east, along the southerly line of those lands now or formerly owned by M. & T. McCabe (1145/821), 40.36 feet to an iron pin set;

Thence, with a new division line through aforesaid New Concord Cemetery Association (1142/165), south 05 degrees – 18 minutes – 56 seconds west, 123.80 feet to the **point of beginning**, and **containing 0.500 acres more or less.**

Subject to all legal highways and easements, whether recorded or implied.

Bearings described herein are based on assumed azimuth and to be used for angle purposes only.

Being part of Auditor's Parcel #66-20-02-27-001 .287 acres
part of Auditor's Parcel #66-24-01-01-000 .213 acres.
