LEGAL DESCRIPTION

Situated in the State of Ohio, County of Muskingum, Township of Union, Village of New Concord, and being part of the southeast quarter of Section 2, Township 1, Range 5, and all of those lands described in Deed Volume 1102, page 153; being further bounded and described as follows:

Commencing at the northeast corner of the southeast quarter of Section 2, thence, south 04 degrees – 35 minutes – 55 seconds west, 577.73 feet to a point on the north line of Westview Drive; thence, south 82 degrees – 59 minutes – 00 seconds west, 290.38 feet along said north line to a point; thence, south 47 degrees – 33 minutes – 56 seconds west, 107.20 feet to a point on the east line of Highland Drive; thence, south 00 degrees – 47 minutes – 46 seconds west, 495.21 feet to the **true point of beginning** for the parcel herein intended to be described;

Thence, leaving said Highland Drive, south 89 degrees – 12 minutes – 25 seconds east, 175.55 feet, along the south line of those lands now or formerly owned by James L. Dooley, Jr. (1794/566), to an iron pin found, passing an iron pin found at 10.00 feet;

Thence, south 02 degrees – 13 minutes – 12 seconds west, 101.16 feet, along the west line of those lands now or formerly owned by D. & J.L. Castor (497/446), to an iron pin found;

Thence, north 88 degrees – 50 minutes – 03 seconds west, 173.04 feet, along the north line of these lands now or formerly owned by New Concord United Methodist Church (1722/1), to an iron pin found on the east line of Highland Drive.

Thence, north 00 degrees – 47 minutes – 46 seconds east, 100.00 feet to the **point of beginning, and containing .402 acres more or less**.

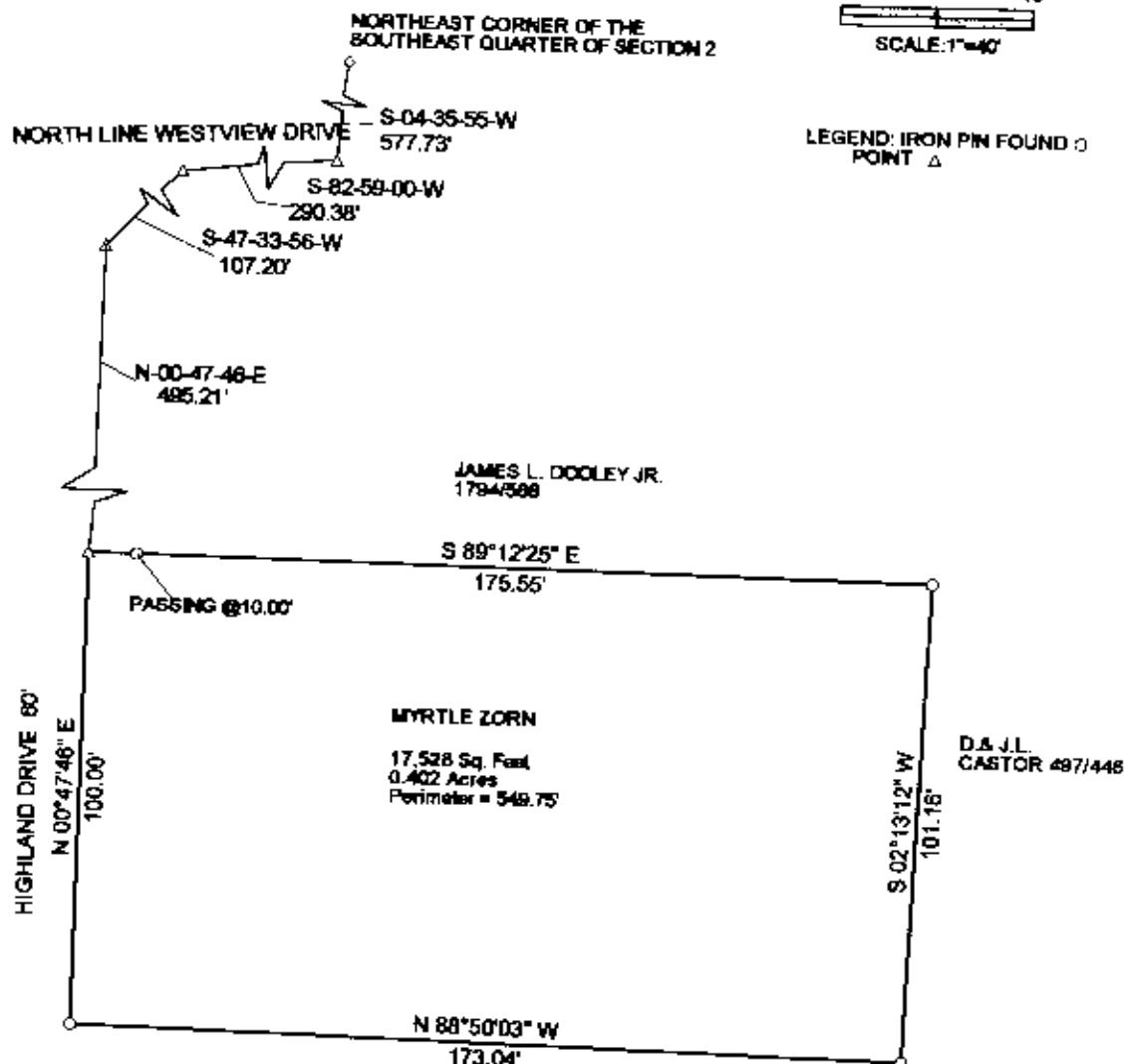
