Situated in section 1, T-1, R-5, Union Township, Muskingum County, Ohio. Being lot 8 of R.W. McCall Allotment recorded in Plat Book 9, page 59 of the Muskingum County deed records, being further described as follows;

Beginning at a set rebar in the Southeast corner of lot 8 in R.W. McCall Allotment (P.B. 9, Pg. 59);

Thence, **S.70°14'03"W.** a distance of **101.22** feet along the North line of McCalls Lane to a found iron pin;

Thence, **N.11°54'28"W.** a distance of **139.55** feet along the East line of lot 7 of R.W. McCall Allotment to a found iron pin on the South line of Hill Crest Drive;

Thence, **N.78°03'59"E.** a distance of **100.76** feet along the South line of said Drive to a point on the west line of the lands of Zandex Health Care Corp. (1072/393);

Thence, **S.11°41'05"E.** a distance of **125.76** feet along said Zandex lands to the point of beginning, passing a set rebar at 8.00 feet.

The above described parcel contains **0.31 acres**, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.

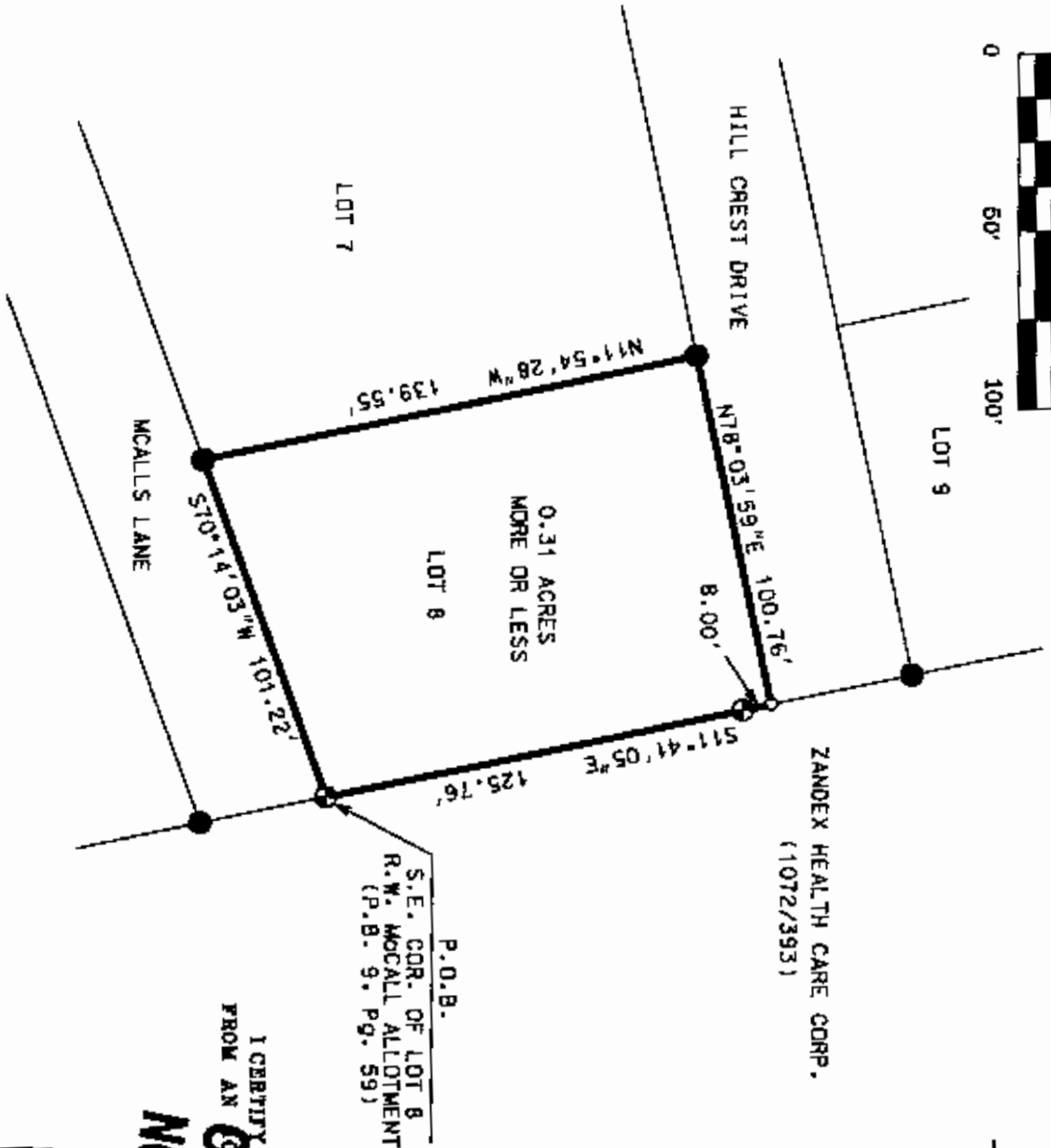
