LEGAL DESCRIPTION FOR G. & S. CHRISTMAN

Situated in the State of Ohio, County of Muskingum, Village of New Concord, and being all those lands intended to be described in Deed Volume 872, page 319 and also being Lot #5 of an unrecorded plat known as Lincoln Place Addition; being further bounded and described as follows:

Commencing at the southeast corner of Lincoln Place Addition, as recorded in Plat Book 5, page 19, thence, south 01 degrees - 30 minutes - 00 seconds east, 416.00 feet along the west line of Comin Street to an iron pin found at the intersection of the west line of said Comin Street and the south line of High Street; thence, south 87 degrees - 30 minutes - 00 seconds west, 142.50 feet to an iron pin set on the south line of High Street, and the true *point of beginning* for the parcel herein intended to be described;

Thence, south 02 degrees - 46 minutes - 10 seconds east, 175.98 feet to an iron pin set;

Thence, south 87 degrees - 30 minutes - 00 seconds west, 46.20 feet to an iron pin set;

Thence, north 03 degrees - 11 minutes - 34 seconds west, 175.99 feet to an iron pin set on the south line of High Street;

Thence, north 87 degrees - 30 minutes - 00 seconds east, 47.50 feet to the *point of beginning*, and containing 0.189 acres more or less.

SUBJECT to all legal highways and easements of record, whether recorded or implied.

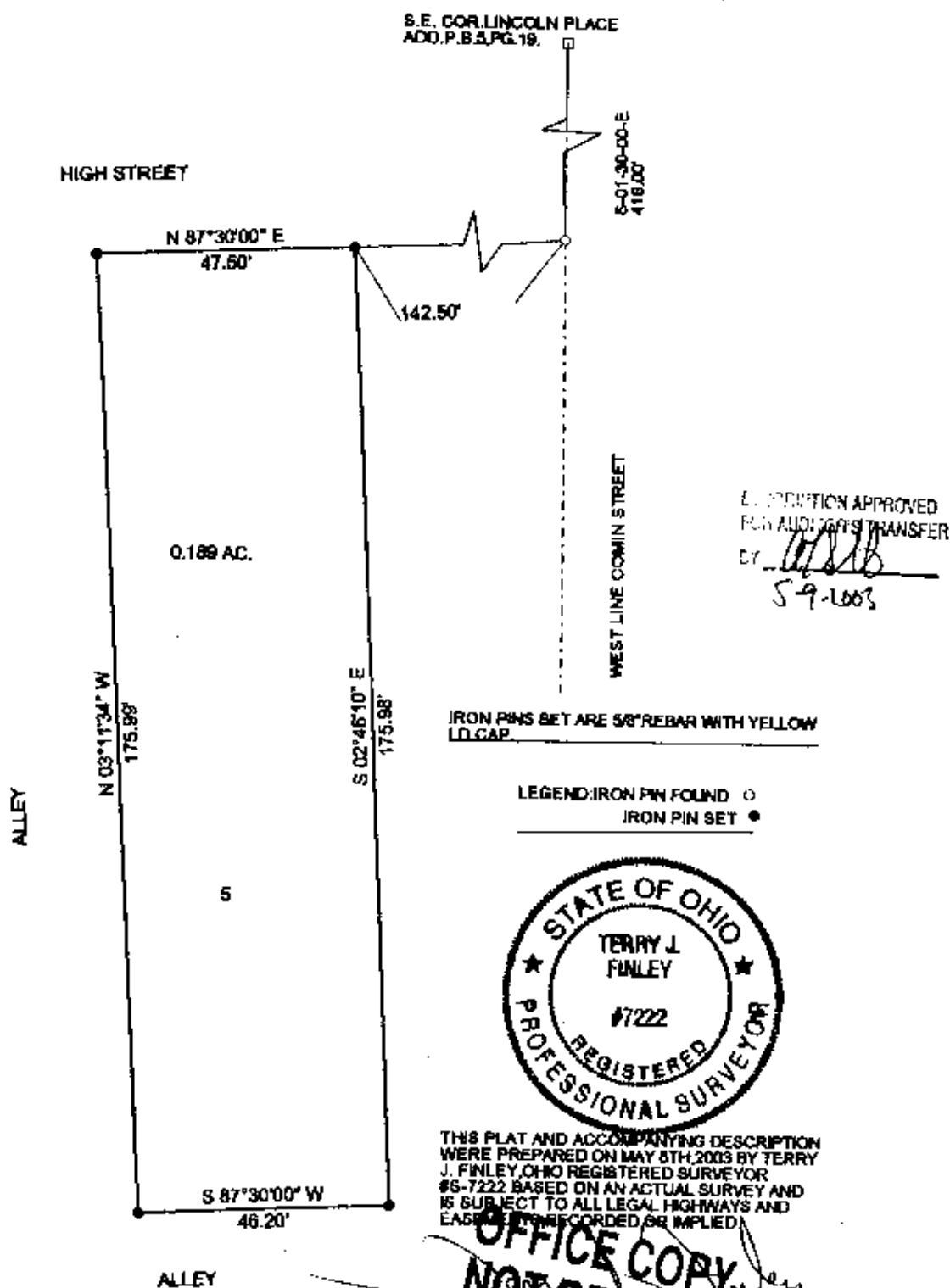
