DESCRIPTION OF A 0.172 ACRE TRACT

Situate in the State of Ohio, County of Muskingum, Village of New Concord, and being part of Section # 1, Township 1 North, Range 5 West in the United States Military District and being all of Parcel # 66-27-06-62 and all of Lot # 48 of an unrecorded plat of Lincoln Place Addition to the Village of New Concord, which was last conveyed to Sheryl Jordan and Lori Jones in Deed Volume 532, Page 484 of Muskingum County records and being more particularly described as follows;

Beginning for Reference at the Southwest corner of Lot # 54 of Lincoln Place Addition (P.B. # 5, Pg. 19), Township 1 North, Range 5 West, thence South 05 degrees 06 minutes 24 seconds East 60.06 feet to a point on the south right of way line of Harper Avenue; thence along said right of way line North 87 degrees 30 minutes 00 seconds East 232.00 feet to an iron pin set and the True Place of Beginning; thence continuing along said right of way line, North 87 degrees 30 minutes 00 seconds East 50.00 feet to an iron pin set; thence along an alley 16.00 feet in width, South 01 degrees 30 minutes 00 seconds East 150.00 feet to an iron pin set; thence leaving said alley along an alley 16.00 feet in width, South 87 degrees 30 minutes 00 seconds West 50.00 feet to an iron pin set; thence leaving said alley along the east line of Lot # 49 and Connie S. Waton and Judy A. Lewis property, North 01 degrees 30 minutes 00 seconds ~~East~~ ^{West} 150.00 feet to an iron pin set at the True Place of Beginning.

Containing 0.172 acres, more or less, subject to all easements, restrictions, or right of ways, either written or implied. All iron pins set are # 5 rebar 30 inches long with a yellow I.D. cap labeled "BINCKLEY S - 7879".

Bearings on this description are assumed on the South Right of Way line of Harper Avenue as being North 87 degrees 30 minutes 00 seconds East and are for angular calculation only.

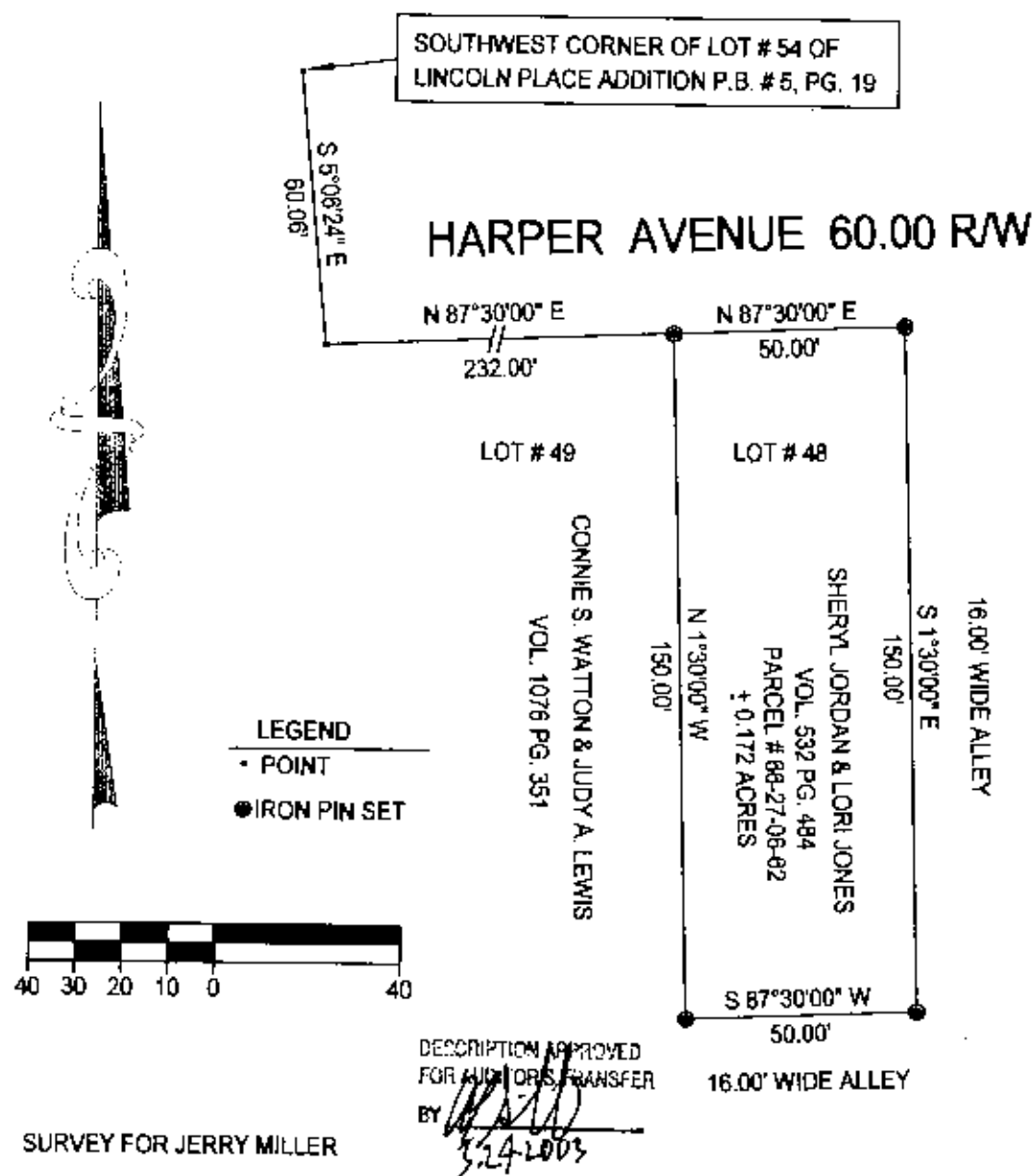
