S. # 22 & 40) S 72° 29' 15" W a distance of 55.69 feet to an iron pin found, Thence with the west line of said Lot # 5 and the lands of now or formerly George R. Wilfong as found in Volume 1069 Page 180 N 09° 05' 06" W a distance of 207.18 feet to an iron pin set, Thence with the south line of an Alley N 71° 39' 59" E a distance of 56.00 feet to the beginning and being all of Lot # 5 of Larimer's Addition as found in Volume 823 Page 284. A. P. # 67-66-28-01-11. Subject to all easements or leases fo public record.

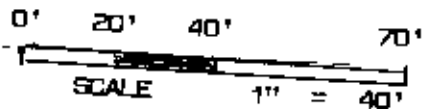
Iron pins set are 5/8 inch rebar 30 inches long, capped SPILKER LS-5862.

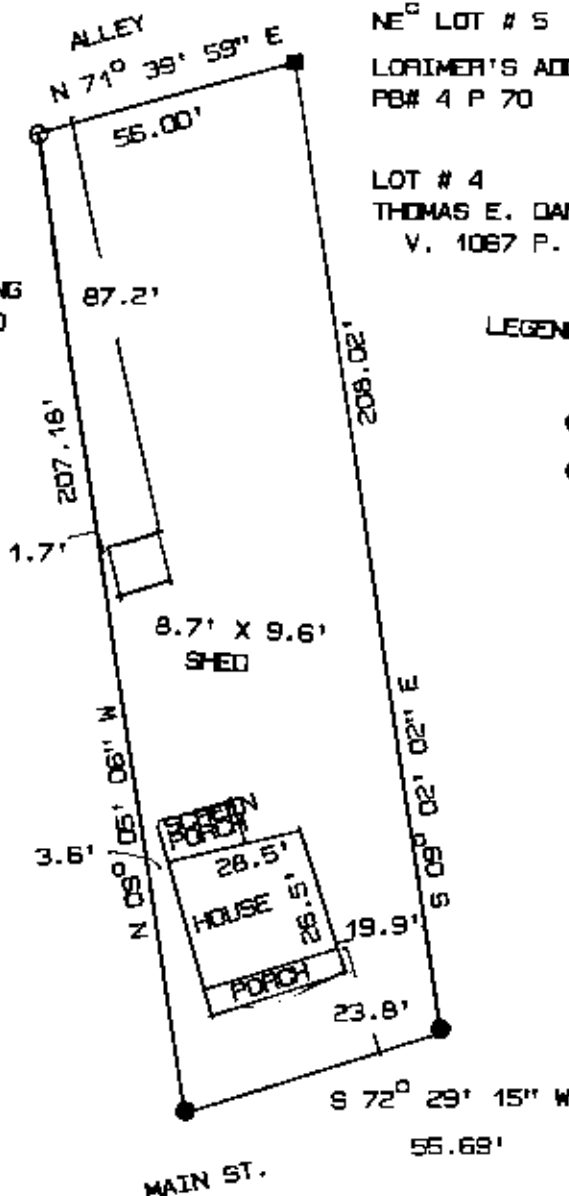
