Situated in the Township of Union, County of Muskingum, and State of Ohio, and being 4.978 acres more or less in the northwest quarter of Section #10 and the southwest quarter of Section #1, Township #1 north, Range #5 west, and being more particularly described as follows:

TRACT #1

Commencing at an iron pin found at the northeast corner of the northwest quarter of Section #10, thence on the north line of the northwest quarter of Section #10, N 83° 09' 43" W, a distance of 839.17 feet to an iron pin set, the BEGINNING, thence S 01° 04' 38" E, a distance of 314.20 feet to an iron pin set, thence N 83° 09' 43" W, a distance of 472.97 feet to a railroad spike set in the center of State Rt. #38, (having passed through an iron pin set at 422.97 feet), thence with the center of State Rt. #83, N 19° 41' 24" W, a distance of 311.41 feet to a railroad spike set, thence N 05° 04' 34" W, a distance of 87.82 feet to an iron pin set, thence N 89° 23' 57" E, a distance of 574.00 feet to an iron pin found, thence S 01° 04' 38" E, a distance of 128.88 feet to the beginning and containing 4.978 acres more or less, and being a part of the property conveyed to Alice Wilson in volume 560, page 522 of the deed records of Muskingum County, Ohio.

There is 3.776 acres more or less in the northwest quarter of Section #10 and 1.202 acres more or less in the southwest quarter of Section #1.

TRACT #2

Situated in the Township of Union, County of Muskingum, and State of Ohio, and being 4.985 acres more or less in the northwest quarter of Section #10, Township #1 north, Range #5 west, and being more particularly described as follows:

Commencing at an iron pin found at the northeast corner of the northwest quarter of Section #10, thence on the north line of the northwest quarter of Section #10, N 83° 09' 43" W, a distance of 839.17 feet to an iron pin set, thence S 01° 04' 38" E, a distance of 314.20 feet to an iron pin set, the BEGINNING, thence S 01° 04' 38" E, a distance of 640.47 feet to an iron pin found, thence N 79° 23' 18" W, a distance of 52.19 feet to a concrete monument found, thence N 82° 25' 29" W, a distance of 153.20 feet to a railroad spike found, thence with the center of State Rt. #83 on a curve to the RIGHT with a radius of 3906.53 feet, chord bearing N 23° 40' 08" W, a distance of 540.63 feet to a railroad spike set, thence with the center of State Rt. #83
