Commencing at the Northwest corner of the Northwest Quarter of Section 13; thence on West line of said quarter section South $0^{\circ} 00' 00''$ West 996.88 feet to an iron pin, the place of beginning; thence North $84^{\circ} 21' 53''$ East 1354.45 feet to an iron pin; thence South $3^{\circ} 10' 58''$ East 879.76 feet to an iron pin set; thence South $86^{\circ} 10' 44''$ East 414.29 feet to an iron pin set; thence South $0^{\circ} 31' 48''$ West along Geyer 875.49 feet to an iron pin; thence North $89^{\circ} 45' 00''$ West along P. & M. Bricker 779.09 feet to an iron pin; thence North $18^{\circ} 06' 34''$ West 1376.54 feet to an iron pin; thence North $88^{\circ} 34' 03''$ West 595.25 feet to an iron pin on the West line of the Northwest Quarter of Section 13; thence North $0^{\circ} 00' 00''$ East 321.91 feet to the place of beginning, containing 38.42 acres more or less.

Commencing at the Northwest corner of the Northwest Quarter of Section 13; thence on the West line of said quarter section South $0^{\circ} 00' 00''$ West 996.88 feet to an iron pin; thence leaving said quarter section line North $84^{\circ} 21' 53''$ East 1354.45 feet to an iron pin found, the place of beginning; thence North $4^{\circ} 03' 06''$ East 43.77 feet to an iron pin; thence South $85^{\circ} 46' 48''$ East 448.97 feet to an iron pin; thence South $14^{\circ} 53' 53''$ East 105.44 feet to a point; thence North $81^{\circ} 27' 12''$ West 182.45 feet to an iron pin, passing an iron pin at 10.00 feet; thence South $6^{\circ} 56' 58''$ West 323.23 feet to an iron pin; thence North $89^{\circ} 25' 03''$ East 208.64 feet to an iron pin; thence South $0^{\circ} 31' 48''$ West 523.14 feet to an iron pin set; thence North $86^{\circ} 10' 44''$ West 414.29 feet to an iron pin set; thence North $3^{\circ} 10' 58''$ West 879.76 feet to the place of beginning, containing 7.97 acres more or less.

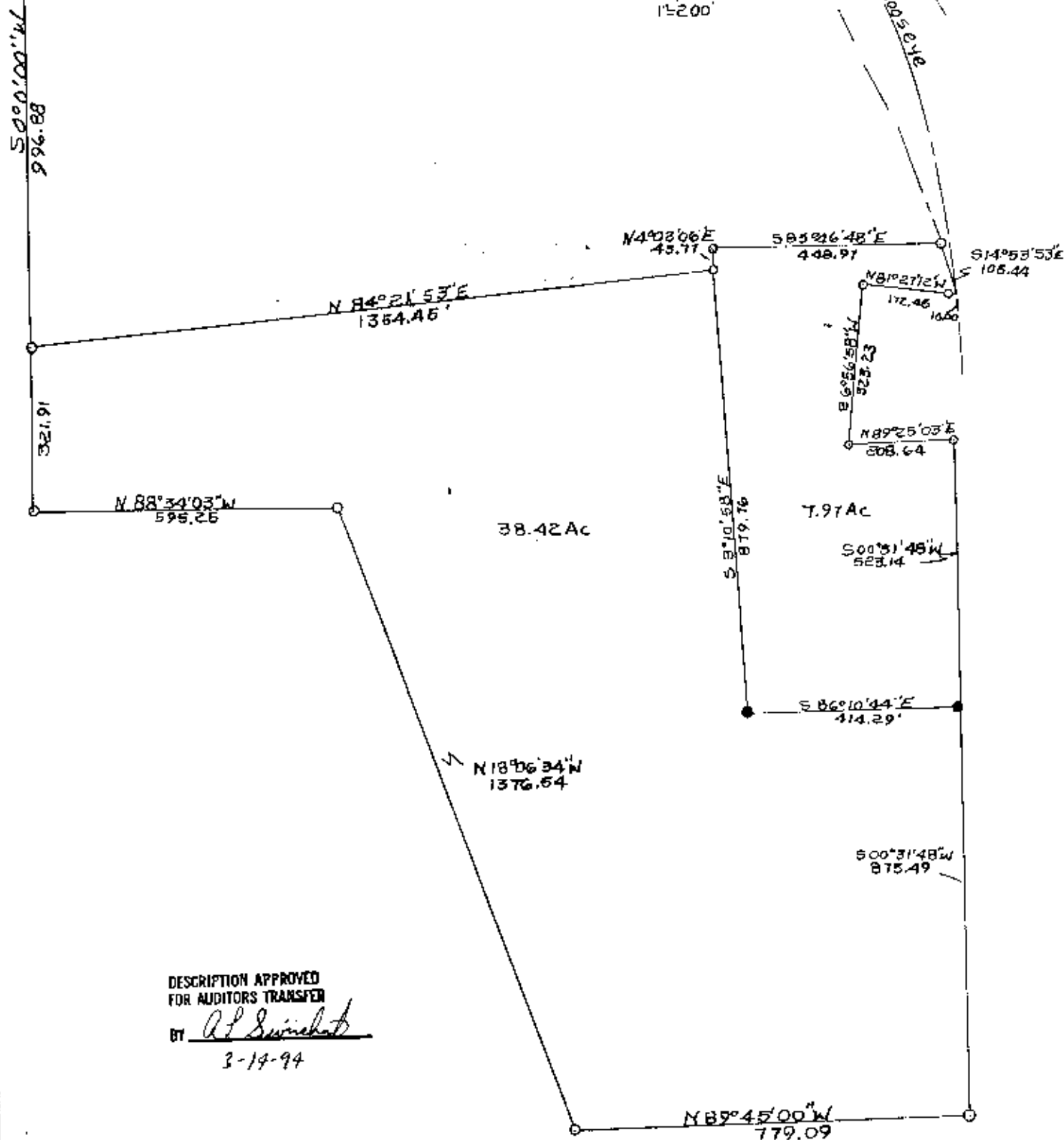
