BEING A PART OF THE WEST HALF OF SECTION 14 AND A PART OF THE NORTH EAST QUARTER OF SECTION 15, TOWNSHIP 1, RANGE 5, OF THE UNITED STATES MILITARY LANDS, UNION TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

BEGINNING AT AN EXISTING STONE AT THE SOUTHWEST CORNER OF SECTION 14; THENCE ALONG THE WEST LINE OF SAID SECTION AND THE EAST LINE OF A TRACT CONVEYED TO J & J BASH RECORDED IN DEED VOLUME 558, PAGE 560 OF THE MUSKINGUM COUNTY DEED RECORDS, NORTH 07 DEGREES 36 MINUTES 54 SECONDS EAST 1375.86 FEET TO A EXISTING IRON PIN (5/8 INCH REBAR) AT THE SOUTHEAST CORNER OF A TRACT CONVEYED TO D. HAYES AS RECORDED IN DEED VOLUME 1050, PAGE 287 OF SAID COUNTY RECORDS; THENCE LEAVING SAID SECTION LINE AND ALONG THE SOUTH LINE OF A 5.010 MORE OR LESS ACRES TRACT SOUTH 82 DEGREES 23 MINUTES 06 SECONDS EAST 324.04 FEET TO AN IRON PIN SET; THENCE ALONG THE EAST LINE OF SAID 5.010 MORE OR LESS ACRES NORTH 07 DEGREES 36 MINUTES 54 SECONDS EAST, PASSING AN IRON PIN SET AT 773.77 FEET, A TOTAL DISTANCE OF 813.77 FEET TO A POINT IN THE CENTER OF COUNTY ROAD 105 (SUNDALE ROAD); THENCE ALONG THE EASTERLY LINE OF A 2.672 MORE OR LESS ACRES TRACT AND FOLLOWING THE CENTER OF SAID COUNTY ROAD THE NEXT SEVEN COURSES AND DISTANCES:

- 1) NORTH 39 DEGREES 28 MINUTES 54 SECONDS EAST 16.51 FEET TO A POINT.
- 2) NORTH 29 DEGREES 52 MINUTES 29 SECONDS EAST 48.14 FEET TO A POINT.
- 3) NORTH 12 DEGREES 50 MINUTES 50 SECONDS EAST 50.66 FEET TO A POINT.
- 4) NORTH 05 DEGREES 41 MINUTES 47 SECONDS WEST 44.47 FEET TO A POINT.
- 5) NORTH 22 DEGREES 10 MINUTES 41 SECONDS WEST 50.27 FEET TO A POINT.
- 6) NORTH 32 DEGREES 01 MINUTES 22 SECONDS WEST 35.30 FEET TO A POINT.
- 7) NORTH 36 DEGREES 06 MINUTES 55 SECONDS WEST 94.27 FEET TO A POINT.

THENCE LEAVING SAID ROAD AND ALONG THE NORTH LINE OF THE SAID 2.672 MORE OR LESS ACRES TRACT SOUTH 57 DEGREES 25 MINUTES 00 SECONDS WEST, PASSING AN IRON PIN SET AT 22.23, A TOTAL DISTANCE OF 304.66 FEET TO AN IRON PIN SET ON THE WEST LINE OF THE ABOVE MENTIONED SECTION 14; THENCE ALONG SAID WEST LINE NORTH 07 DEGREES 36 MINUTES 54 SECONDS EAST 352.91 FEET TO AN IRON PIN SET AT THE NORTHWEST CORNER OF THE SAID SOUTHWEST QUARTER; THENCE ALONG THE SOUTH LINE OF THE NORTHEAST QUARTER OF SECTION 15 NORTH 82 DEGREES 14 MINUTES 10 SECONDS WEST 189.45 FEET TO AN IRON PIN
