SITUATED IN THE TOWNSHIP OF UNION, COUNTY OF MUSKINGUM, STATE OF OHIO, AND BEING A PART OF THE NORTHEAST QUARTER OF SECTION 11, TOWNSHIP 1N, RANGE 5W, OF THE UNITED STATES MILITARY LANDS, ALSO BEING A PART OF THE TOWNSHIP OF WESTLAND, COUNTY OF GUERNSEY, STATE OF OHIO, AND BEING A PART OF THE SOUTHWEST QUARTER OF QUARTER TOWNSHIP 2, TOWNSHIP 1N, RANGE 4W, OF THE UNITED STATES MILITARY LANDS, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS;

COMMENCING AT AN IRON PIN FOUND MARKING THE NORTHEAST CORNER OF SECTION 11, BEING ON THE LINE BETWEEN GUERNSEY AND MUSKINGUM COUNTIES, AND BEING ON THE WEST LINE OF QUARTER TOWNSHIP 2;

THENCE, S 01°05'21" E 908.61 FEET WITH SAID COUNTY LINE, SECTION LINE, AND SAID QUARTER TOWNSHIP LINE, TO AN IRON PIN SET IN THE CENTERLINE OF AN EXISTING GRAVEL DRIVE ON THE WEST LINE OF SAID PARCEL CONVEYED TO TEAGUE, THE SAME BEING THE EAST LINE OF SAID PARCEL CONVEYED TO LAKE LAND INVESTMENT CORPORATION, AND BEING THE PRINCIPLE PLACE OF BEGINNING OF THE TRACT HEREIN TO BE DESCRIBED;

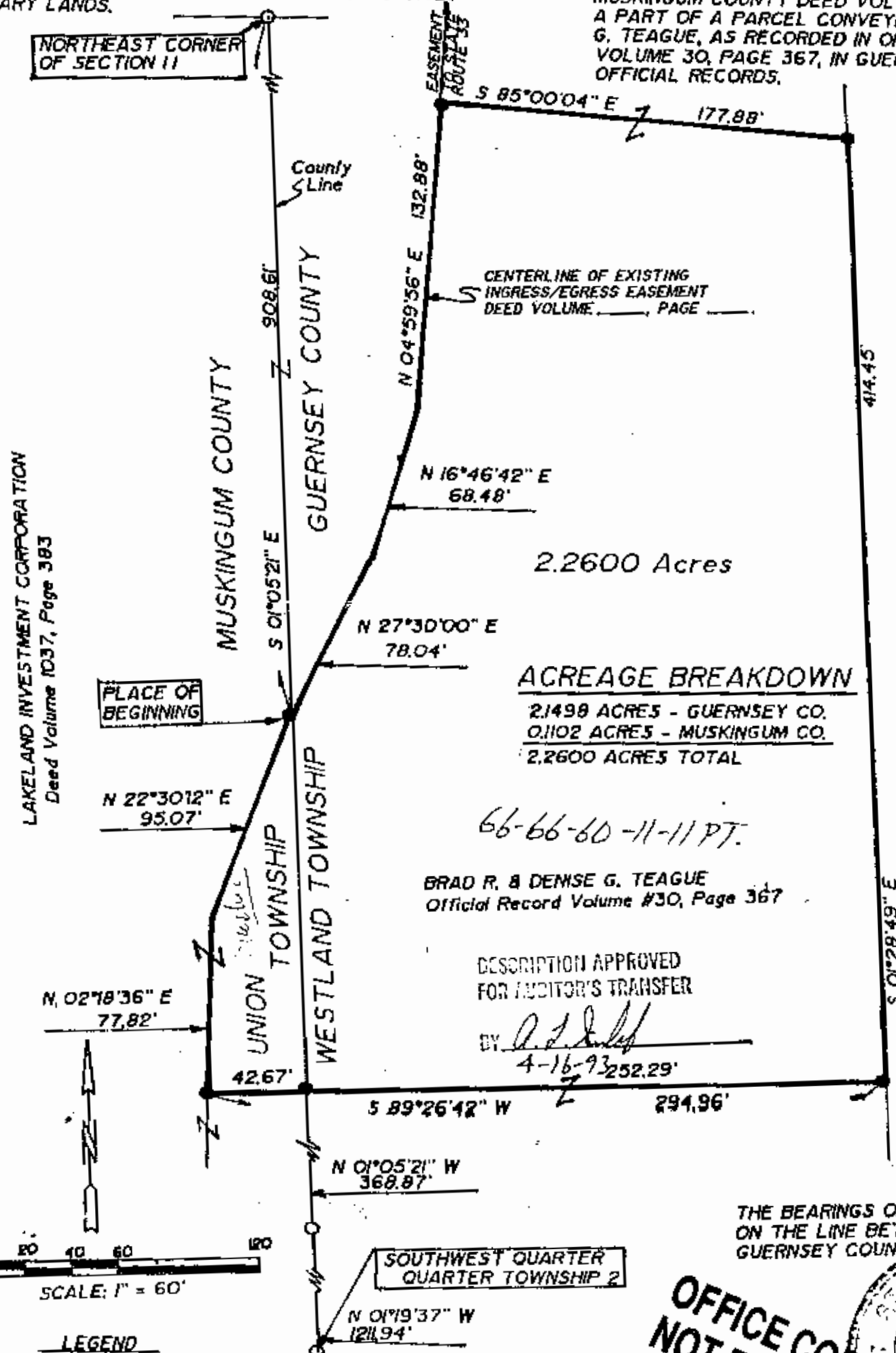
