Situated in the Township of Union, County of Muskingum, State of Ohio and being 3.154 acres in the northwest quarter of section 12 of Township 1 north Range 5 west of the United States Military District and being more particularly described as follows,

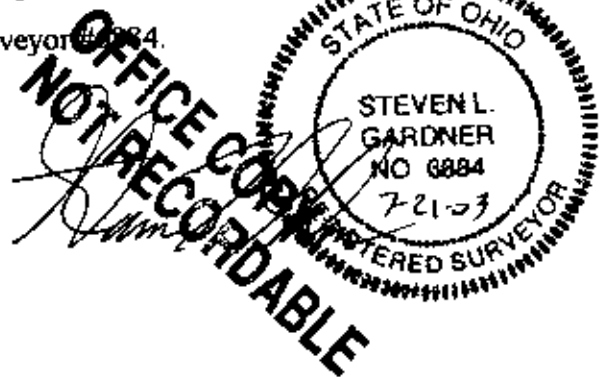
Commencing at a 3/4 inch iron pipe found at the northwest corner of the northwest quarter of said section 12 thence with the west line of said northwest quarter S 02° 34' 12" W a distance of 1684.66 feet to a one inch iron pipe found the **BEGINNING** thence with the lands of James R. Murry as recorded in deed volume 1128 page 29 N 58° 12' 29" E a distance of 231.56 feet to a one inch iron pipe found thence with the lands of Marjorie M. and Robert L. Johnson as recorded in deed volume 535 page 693 S 58° 41' 37" E a distance of 188.80 feet to a point in the center of County road 55 having passed through a one inch iron pipe found at 161.58 feet thence with the center of said road and with the lands of Joe Pittman as recorded in deed volume 1081 page 77 S 28° 58' 46" W a distance of 699.22 feet to a point thence leaving said road and with the lands of C. & S. Blackwood as recorded in deed volume 681 page 272 N 44° 40' 23" W a distance of 62.24 feet to an iron pin set having passed through an iron pin set at 20.00 feet thence continuing with the lands of said Blackwood and with the west line of said northwest quarter N 2° 34' 12" E a distance of 463.20 feet to a 3/4 inch iron pipe found thence continuing with said quarter line and with the lands of Daniel J. and Dorothy K. Garber as recorded in deed volume 853 page 165 N 02° 34' 12" E a distance of 80.86 feet to the **BEGINNING** and containing 3.154 acres.

1.133 acres being all of the property conveyed in tract one of deed volume 1136 page 388 and being all of auditors parcel # 66-60-12-13-000.

2.021 acres being all of the property conveyed in tract two of deed volume 1136 page 388 and being all of auditors parcel # 66-60-12-14-000.

Subject to all leases or easements of record. Iron pins set are 5/8 inch rebar, 30 inches long capped "GARDNER PS-6884". Bearings are based on the grid meridian of the Ohio state plane south coordinate zone as determined by GPS observations. A survey of the above described property was made on July 21, 2003 by Steven L. Gardner, registered surveyor # 6884.

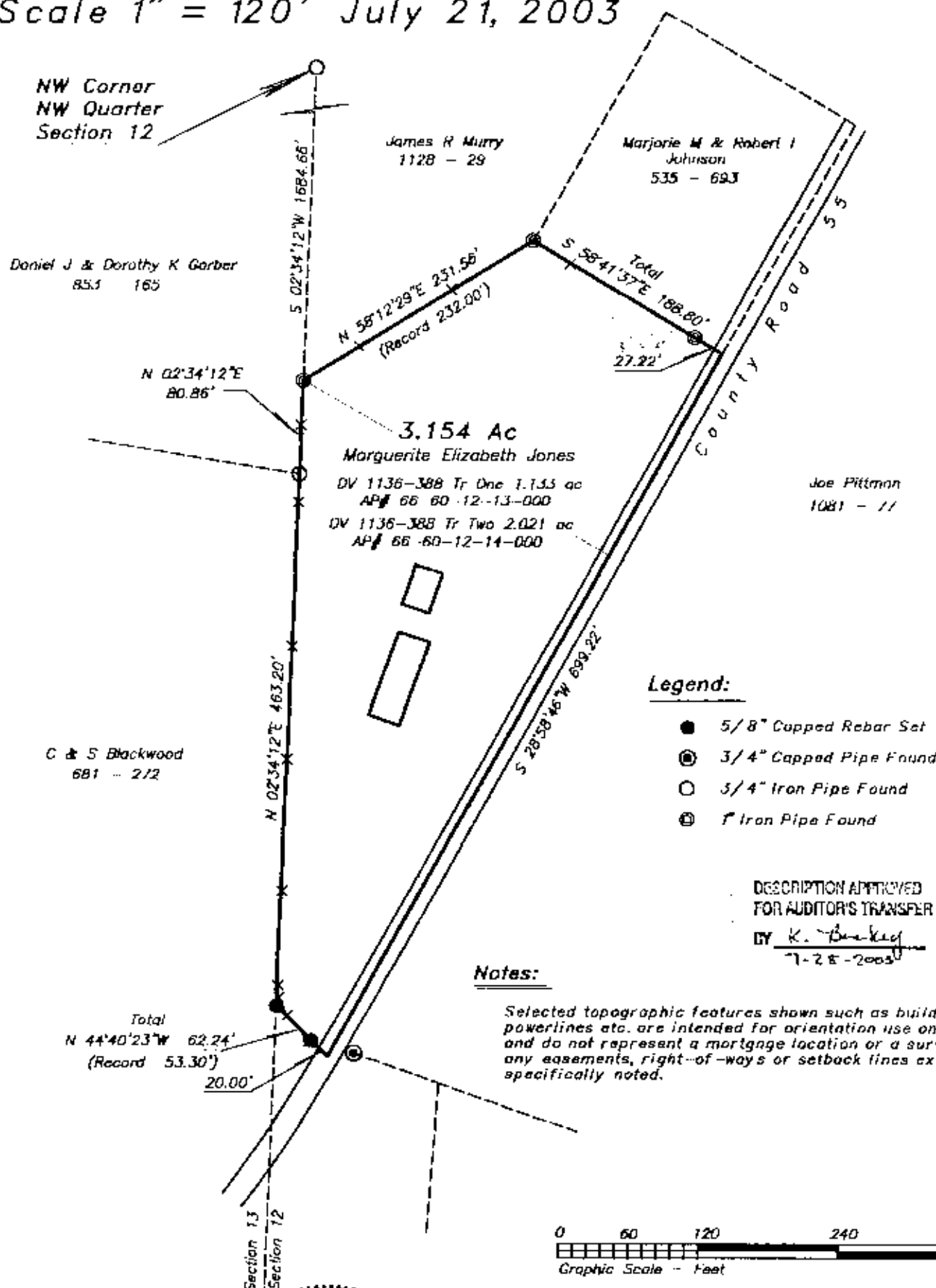
