COMMENCING AΤ AN IRON PIN FOUND AT THE SOUTHEAST CORNER OF NORTHEAST QUARTER OF SAID SECTION 17, THENCE, ALONG THE EAST LINE OF SAID SECTION, NORTH CO DEGREES - CO MINUTES - OI SECONDS EAST, 377.71 FERT TO A POINT, 11 FEET WEST OF THE CENTERLINE OF SOUTHERN ROAD, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, SOUTH 86 DEGREES - 24 MINUTES - 01 SECONDS WEST, 153.85 FEET TO AN IRON PIN SET, PASSING AN IRON PIN FOUND AT 8.96 FEET; THENCE, NORTH 03 DEGREES - 31 MINUTES - 03 SECONDS WEST, 232.56 FEET TO AN IRON PIN SET; THENCE, SOUTH 88 DEGREES - 33 MINUTES - 01 SECONDS WEST, 97.99 FEET TO AN IRON PIN SET; THENCE, NORTH 49 DEGREES - 28 MINUTES - 51 SECONDS WEST, 217.66 FRET TO AN IRON PIN SET; THENCE, NORTH 03 DEGREES - 31 MINUTES - 03 SECONDS WEST, 286.90 FEET TO AN IRON PIN SET; THENCE, NORTH 86 DEGREES -24 MINUTES - 01 SECONDS EAST, 449.72 FEET TO A POINT IN THE CENTER OF SAID SOUTHERN ROAD, PASSING AN IRON PIN SET AT 424.72 FEET; THENCE, SOUTH OO DEGREES - 00 MINUTES - 01 SECONDS WEST, 675.99 FEET TO THE POINT OF BEGINNING, AND CONTAINING 4.997 ACRES MORE OR LESS.
