LEGAL DESCRIPTION

Situated in the State of Ohio, County of Muskingum, Township of Union, and being part of the northeast quarter of Section 17, Township 1, Range 5, and being part of those lands intended to be described in Deed Volume 2465, page 287, First Parcel; being further bounded and described as follows:

Commencing at the northeast corner of Section 17, thence, north 87 degrees – 56 minutes – 30 seconds west, 923.15 feet to a railroad spike set in Cove Lane, and the **true point of beginning** for the parcel herein intended to be described:

Thence, south 02 degrees – 22 minutes – 48 seconds west, 998.56 feet, along the west line of those lands now or formerly owned by K. Caldwell (1649/354) and F. & C. Caldwell (1126/204), to a point, passing an iron pin found at 409.15 feet and an iron pin set 997.23 feet;

Thence, continuing along the northerly and westerly line of said F. & C. Caldwell lands, the following two (2) courses and distances:

1. North 89 degrees – 30 minutes – 15 seconds west, 535.39 feet to a point, from which an iron pin set bears south 83 degrees – 29 minutes – 22 seconds west, 0.44 feet;
2. South 10 degrees – 33 minutes – 37 seconds west, 1637.47 feet to a point, from which an eight (8) inch post bears south 10 degrees – 33 minutes – 37 seconds west, 1.60 feet;

Thence, north 87 degrees – 38 minutes – 46 seconds west, 955.84 feet, along the northerly line of those lands now or formerly owned by S. & D. Bost (1088/506) and C. Price (1794/983), to an iron pin set, passing an iron pin found at 114.10 feet;

Thence, north 02 degrees – 37 minutes – 38 seconds east, 2097.24 feet, along the east line of those lands now or formerly owned by J. Evans (1104/598), and K. & J. Ritchey (2071/744), to an iron pin found, passing a stone found at 496.30 feet;

Thence, north 02 degrees – 19 minutes – 58 seconds east, 527.97 feet, along the east line of those lands now or formerly owned by D. Starcher (2281/818), to an iron pin found, passing an iron pin found at 493.07 feet;

Thence, along the southerly line of those lands now or formerly owned by A. Chandler (2291/797), B. & K. Bradley (2036/882), W. Funk (1158/106) and Rebecca Ritchey and Vonda Stewart (2465/290), south 88 degrees – 01 minutes – 41 seconds east, 1715.37 feet to the **point of beginning**, and **containing 79.445 acres more or less excepting therefrom a 5.979 acre parcel conveyed to K. Ritchey and K. Porter (1871/504) and being parcel #66-80-17-05-002 leaving 73.466 acres remaining.**


