Being a part of the Northwest quarter of section 18, Township 1, North: Range 5, West Union Township, Muskingum County, State of Ohio and being the tract last transferred to Beula Dickson as recorded in deed book 623 page 172 of the said county records and being further described as follows.

Beginning at an iron pin found at the Southeast corner of the Northwest quarter of section 18, Thence along the South line of said quarter section North 87 degrees 20 minutes 48 seconds West 613.80 feet to a stone found on the Northwest corner of a tract recorded in deed book 1081 page 212, passing a stone found at 328.41 feet. Thence continuing along the said South line North 86 degrees 49 minutes 12 seconds West 248.15 feet to a stone found at the Southeast corner of a 140 acre tract as recorded in deed book 932 page 498. Thence along the East line of said tract North 17 degrees 23 minutes 58 seconds East 1369.71 feet to a 5/8" iron pin set. Thence South 87 degrees 07 minutes 35 seconds East 495.00 feet to a stone found on the East line of said Northwest quarter and the West line of lot 6. Thence along the said line South 01 degrees 51 minutes 44 seconds West 1325.10 feet to the place of beginning, passing an iron pin found on the Northwest corner of fractional lot 15 at 1131.72 feet and containing 20.6581 acres more or less. 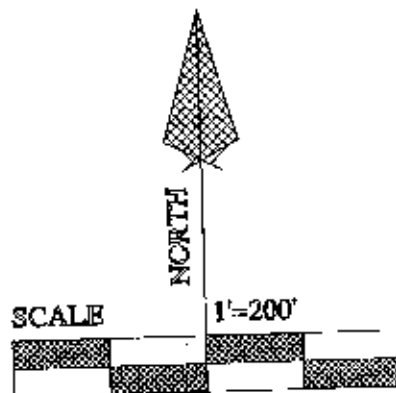
